I, MD Mahfuz, son of MD Kurebani, resident of Thokar, Tumbajot, under Pradhan Nagar P.S., Dist. Darjeeling, Siliguri, would like to inform you that on 13.02.2026 at about 8:20 PM, while I was going from Mahabirasthan towards Thokar, and when I reached the crossing near 4th Mahananda Bridge near Kholai Basti, one woman and three men, namely (1) Nagu Khatun, (2) Babul, (3) Momira Hossain and two others, suddenly attacked upon me.

They beaten me mercilessly and caused severe injuries on my right eye and right side of my head above the ear. I have taken treatment from Siliguri District Hospital and was admitted there for one day. The medical certificate and diagnostic reports are enclosed herewith.

They also snatched away Rs. 50,000/- from the right pocket of my pant and 15 grams gold chain from my neck and one wrist watch. They threatened me to leave this place otherwise they will kill me and also threatened me that if I meet or contact with MD Imtiaz, MD Rizwan and Sah Faisal of South Ambedkar Colony, then they will continue this activity unless I leave them. It is to be noted here that I came from Bihar to earn my livelihood. MD Rizwan is a co-villager from my home village in Bihar. I have been acting as his local guardian here. Recently, MD Rizwan introduced me to two individuals, Sah Faisal and MD Imtiaz. MD Rizwan is my co-villager of my village situated in Bihar and I am treating him as local guardian and MD Rizwan introduced me with Sah Faisal and MD Imtiaz but I do not know the reason what is their problem so that they attacked upon me and I have got severe injury on my right eye and right side of head so above ear and I have taken treatment from Siliguri District hospital and was admitted there for 1 day.

Therefore, I request you to kindly investigate the matter and do the needful.
