It is to inform you that I, **Debraj Das**, S/O- Kartik Ch Das, DE & SM, Pradhannagar CCC; being empowered by the Electricity Act 2003, do hereby lodge a complaint against **BIJAY KUMAR GUPTA**, S/O- LT D.S GUPTA, Address- L3 Building, Eris Milk Shop, Hill Cart Road, opp Petrol Pump, W No. 03, Dist-Darjeeling, Pin-734003 for **reconnecting a deemed disconnected meter illegally and unauthorizedly and using it for commercial purpose.**

Today i.e, on **16.02.2026**(13.45 hrs), I came to L3 Building, Eris Milk Shop, Hill Cart Road, opp Petrol Pump, W No. 03, P.S - Pradhannagar, Dist-Darjeeling; in my officially hired vehicle for a routine inspection. I was accompanied by (i) Rabi Sankar Singh, Sr OE, Pradhannagar CCC, (ii) Sourav Saha Roy, Sr OE, Pradhannagar CCC & other technical staffs of Pradhannagar CCC.

On inspection of the premises, after observing all formalities, I found that the meter **P1686649** (Consumer Name- **BIJAY KUMAR GUPTA**, Commercial Urban Category, Con Id-**400417814**, Date of disconnection-**30.10.2024**, Status- **Deemed**) has been reconnected illegally and unauthorizedly and is being used for Commercial purpose (Eris Milk Shop).

The meter **P1686649** has an outstanding due of **Rs.7739.67/-** and **LPSC-Rs.1632.22/-** (as on 16.02.2026)
I disconnected the connection of **BIJAY KUMAR GUPTA** & seized the meter **P1686649**, after preparing the seizure list duly signed by the witnesses. Local people were present but none appeared.

Seized Articles:

- 1 phase energy meter **P1686649**, 240V, 5-30A, Make- Himachal(L/R-20364 KWH)

BIJAY KUMAR GUPTA was not present at the premises. His son- **Diwash Gupta** (8388884128) received the Notice, Inspection Sheet & Seizure list.

As such, **BIJAY KUMAR GUPTA**, has reconnected a deemed disconnected meter illegally and unauthorizedly and using it for Commercial purpose and is liable for prosecution U/S **138 1(b) & 135 1(e)** of Electricity Act 2003. Hence, you are requested to treat this as FIR.
