Sir

In producing herewith 01 (one) accused person namely Md Firoj @ Raj (27 years) S/O Md Ainul of 8 th Mile, near Petrol Pump, PS+Dist. Kalimpong under arrest and the following articles under seizure viz (i) one (01) iron made improvised small fire arm measuring approx 25 cm in length including its 10 cm iron made pistol grip, having approx 16.5 cm barrel, trigger, firing pin and firing hammer in proper working condition - marked as exhibit "A" and (ii) 01 (one) live ammunition- marked as exhibit - "B". I, ASI Biplab Kr Das of Pradhan Nagar PS, SPC do hereby lodged this written complaint against the above mentioned arrested accused person namely Md Firoj @ Raj (27 years) S/O Md Ainul of 8 th Mile, near Petrol Pump, PS+Dist. Kalimpong to the effect that tonight i.e. on 16.02.26 at 21.35 hrs, I received a specific secret source information that one person would be coming to Siliguri from Kalimpong side with illegal fire arm with a view to sell the same to his designed customer or to commit any heinous crime at Siliguri Junction area. Accordingly, I diarized the information in PS General diary vide Pradhan Nagar PS GDE No. 1013 dated 16.02.26 and informed the fact to you. As per your kind order and direction myself along with SI Ribam Lepcha, ASI Prabal Sarkar, ASI Bikash Roy and force left for Naka Point at Circuit House More, Champasari with investigation kit to work out the information by Govt. vehicle vide Pradhan Nagar GDE No 1014 dated 16.02.26 and MCC No 269/26 dated 16.02.26.

Under this circumstance any search warrant or authorization for search cannot be obtained for want of time. So we had to move fast without affording the miscreant, the opportunity for the concealment of evidence or facility for his escape. On the way to Circuit House More, I requested night RT Van Officer SI Debabrata Khan to come to Circuit House More under PS- Pradhan Nagar, Dist. Darjeeling to accompany with us and also inform one videographer namely Somnath Chatterjee S/O Sushil Chatterjee of Santi Nagar, Bou Bazar, PS- Bhakti Nagar, Dist. Jalpaiguri and requested him to come to Circuit House More, Champasari with his camera for the purpose of videography if required. After arrival at Circuit House More, Champasari More, I contacted with one independent person namely Pankaj Saha (39 yrs) S/O Pradip Kr Saha of Bagha Jatin colony, Road No-45/04, Ward No-45, PS- Pradhan Nagar, Dist. Darjeeling and requested them to remain present and act as witness during search and seizure if required upon which they agreed. Then, I contacted with my source while he stated that the person possessing illegal fire Arms was coming from Kalimpong side. Then, we started to NAKA checking on NH-10 at Circuit House More, Champasari under PS Pradhan Nagar, Dist. Darjeeling. At around 22.55 hrs I received an information from my source that the person possessing illegal fire arm was coming down to Siliguri from Kalimpong by a small passenger vehicle and got down at Bhakti Nagar and waiting there. I shared the information with my raiding team. After a while my source informed me that the person possessing illegal fire arm boarded in a passenger three wheeler Auto Rickshaw having No. WB 73 F 0316 and proceeding towards Champasari More side. I again alerted my raiding team and started NAKA Checking on NH-10 at circuit House More, Champasari with due care and caution. At around 23.15 hrs, we stopped one three wheeler Auto Rickshaw having the same Reg number as mentioned above and found one person was seating in the back side of the Auto Rickshaw.

Thereafter, we disclosed our identities as Police personnel (as we were in civil dress for our convenience). On interrogation, he disclosed his identity as noted above. As per source information that the possessed fire arm and ammunition. Hence, immediately, I searched him and recovered the following articles viz - (i) one (01) iron made improvised small fire arm measuring approx 25 cm in length including its 10 cm iron made pistol grip, having approx 16.5 cm barrel, trigger, firing pin and firing hammer in proper working condition and (ii) 01 (one) live ammunition from his exclusive possession. On demand he failed to produce any document in respect of the fire Arm and ammunition which was found in his exclusive and conscious possession. Accordingly, I seized the above mentioned articles from his possession in presence of independent witnesses noted above under proper seizure list and duly signed by the witness and acknowledge by the accused person. The search seizure and label were made in between 23.25 hrs to 23.45 hrs at the spot under the coverage of videography executed by the above mentioned videographer as per norms of BNSS. On further interrogation he admitted that he came to Siliguri to deliver the same to his designed customer at Siliguri Junction for his wrongful gain.

Thus, when his involvement in carrying and possessing illegal Fire arm and ammunition was established, I then arrested him under proper memo of arrest and observing all the formalities for violating the norms of Arms Act. I informed him regarding grounds of his arrest and also issued copy of memo of arrest and ground of arrest to him. It should be mentioned here that the Auto Rickshaw driver namely Mithun Sekh (26 yrs) S/O Kismat Sekh of Dagapur, PS- Pradhan Nagar, Dist. Darjeeling found innocent and his involvement with the accd person possessing fire arm could not be proved and he stood as witness of the search and seizure.

Under the above noted facts and seizure of incriminating articles, there is strong reason to believe that the said accused person namely Md Firoj @ Raj (27 years) S/O Md Ainul of 8 th Mile, near Petrol Pump, PS+Dist. Kalimpongis desperate and dangerous in nature and he was carrying the said Fire arm and live ammunition with an objective to sell the same or to commit any heinous crime in the locality.

As he willfully violated the regulation of Arms Act, I, therefore pray before your good self that a specific case may kindly be initiated against the accused person namely Md Firoj @ Raj (27 years) S/O Md Ainul of 8 th Mile, near Petrol Pump, PS+Dist. Kalimpong under proper section of law and its investigation may kindly be arranged.
