In producing herewith six (06) accused persons namely (i) Sunil Tamang @ Chepe (29 yrs) S/O Shankar Tamang of Sishudangi, Milan More, PS- Pradhan Nagar, Dist. Darjeeling (ii) Subhash Oraon (29 yrs) S/O Late Rahul Oraon of Ramkrishna Colony, near SDO Office, Malbazar, PS- Malbazar, Dist. Jalpaiguri (iii) Karan Subba (30 yrs) S/O Late Ganga Subba of Gurung Busty near Ram Narayan Math, Ward No-03, PS- Pradhan Nagar, Dist. Darjeeling (iv) Pankaj Singh (29 yrs) S/O Late Ramasish Singh of Gurung Busty near Ram Narayan Math, Ward No-03, PS- Pradhan Nagar, Dist. Darjeeling (v) Bittu Khan (27 yrs) S/O Late Moti Khan of South Ambedkar Colony, PS- Pradhan Nagar, Dist. Darjeeling and (vi) Dhiraj Shaw (24 yrs) S/O Late Sagar Shaw of Shakti Nagar, PS- Raiganj, Dist. Uttar Dinajpur under arrest along with the following seizure articles viz :- (i) One sharp cutting weapon locally called as "Hasua" measuring approx 54 cm including its wooden Butt, (ii) One sharp cutting weapon locally called as "Sabol" measuring approx 56 cm (iii) One iron made blue colour "Plus" measuring approx 44 cm in length (iv) one iron made hammer measuring 30 cm in length include its orange colour handle (v) one plastic made torch light and (vi) one multi colour nylon bag. I, ASI Bikash Roy of Pradhan Nagar PS, SPC do hereby lodge this written complaint against the above noted six (06) arrested accused persons and others 06/07 unknown miscreants who involve in this crime, to the effect that on 17.02.26 at 00.25 hrs I received a specific source information that about 12/13 miscreants equipped deadly weapons assembled in an abandon building at near old SJDA office, Siliguri Junction under PS- Pradhan Nagar, Dist. Darjeeling and they are making preparations for committing Dacoity at Siliguri Junction area. Accordingly, I diarized the fact in P.S. General diary vide Pradhan Nagar PS GDE No. 1027 dated 17.02.2026 and informed the matter to you. As per your kind order and direction, I along with ASI Biplab Kr Das, ASI Prabal Sarkar and force all of Pradhan Nagar PS, SPC left for Siliguri Junction under PS- Pradhan Nagar, Dist. Darjeeling by Govt. vehicle with investigation kits to verify the veracity of the information without any search warrant or authorization for search which could not be possible to obtain from a competent authority for sudden development of a sensitive information and not to afford them opportunity for concealment of evidence or facility for their escape. I also informed night RT van officer SI Debabrata Khan and requested him to come to Himachal Colony to accompany with us. On the way to Siliguri Junction I informed one Videographer namely Somnath Chatterjee S/O Sushil Chatterjee of Arabinda Pally, Gokhel Road, Ward No. 22, PS. Siliguri, Dist.- Darjeeling and requested him to come to Siliguri Junction with his camera for the purpose of videography if required.

At around 00.45 hrs we arrived at Siliguri Junction under PS Pradhan Nagar, Dist. Darjeeling and after a while night RT van officer SI Debabrata Khan arrived there and accompanied with us. I shared the information with them and briefed them properly. Then, I contacted my source and from a considerable distance he pointed to the place where the miscreants were assembled. Then, I requested two available independent witnesses namely (i) Pranay Sen (43 yrs) S/O Arun Sen of Chayan Para, Dabgram, PS-Bhakti Nagar, Dist. Jalpaiguri and (ii) Md Sudha (19 yrs) S/O Sk Hafijuddin of Ratanlal Busty, Ward No-01, PS- Pradhan Nagar, Dist. Darjeeling and shared the information with them and requested them to remain present and act as witness if any search and seizure would be made, upon which they agreed.

Thereafter, we proceeded towards the place being identified by the source and cordoned the place from every corner with due care and caution and from a considerable distance. We noticed that 12/13 persons were assembled in an abandon room near old SJDA office, Siliguri Junction under PS- Pradhan Nagar, Dist. Darjeeling and they were whispering in a low voice. On seeing police personnel approaching towards them, they tried to flee away from the spot but on hot chase we managed to apprehended above noted six (06) accused persons while 06/07 others unknown miscreants managed to flee away taking the advantage of open place and darkness.

Thereafter, we disclosed our identities as Police personnel (as we were in civil dress for our convenience). On interrogation, they disclosed their identities as noted above. On search recovered the above noted weapon of offence from their joint possession which they kept concealed inside one multi color nylon bag.

On further interrogation, they furnished incoherent statements and failed to give any satisfactory reply for their presence with deadly weapons in such deaf hour of night. Finally they disclosed that they along with 06/07 of their associates assembled there and were making preparations for committing Dacoity at Siliguri Junction and its surrounding area. Accordingly, I seized the above mentioned weapons of offence from their joint possessions under proper seizure list in between 01.15 hrs. to 01.45 hrs. at the spot in presence of witnesses and duly signed by the witnesses and acknowledged by the accused persons and subsequently arrested them under proper memo of arrest and observing all the formalities of arrest. They are informed on the ground of their arrest. The whole process of search and seizure were made under the coverage of videography as per norms of BNSS executed by one Somnath Chatterjee S/O Sushil Chatterjee of Arabinda Pally, Gokhel Road, Ward No. 22, PS. Siliguri, Dist.- Darjeeling and brought all the six (06) arrested accused persons along with seized articles to Pradhan Nagar Police Station for further investigation. From the above noted facts and seizure of incriminating articles there is strong reason to believe that all the above noted six (06) accused persons along with 06/07 of their associates who fled away, gathered there equipped with deadly weapons at such deaf hour of night and taking preparation to commit Dacoity in a nearby affluent area at Siliguri Junction.

Under the above circumstances, I pray before you that a specific case under proper section of law may kindly be started against the above noted six (06) arrested accused persons namely (i) Sunil Tamang @ Chepe (29 yrs) S/O Shankar Tamang of Sishudangi, Milan More, PS- Pradhan Nagar, Dist. Darjeeling (ii) Subhash Oraon (29 yrs) S/O Late Rahul Oraon of Ramkrishna Colony, near SDO Office, Malbazar, PS- Malbazar, Dist. Jalpaiguri (iii) Karan Subba (30 yrs) S/O Late Ganga Subba of Gurung Busty near Ram Narayan Math, Ward No-03, PS- Pradhan Nagar, Dist. Darjeeling (iv) Pankaj Singh (29 yrs) S/O Late Ramasish Singh of Gurung Busty near Ram Narayan Math, Ward No-03, PS- Pradhan Nagar, Dist. Darjeeling (v) Bittu Khan (27 yrs) S/O Late Moti Khan of South Ambedkar Colony, PS- Pradhan Nagar, Dist. Darjeeling and (vi) Dhiraj Shaw (24 yrs) S/O Late Sagar Shaw of Shakti Nagar, PS- Raiganj, Dist. Uttar Dinajpur and others 06/07 unknown miscreants who fled away from the spot and arranged for its investigation.
