Subject: Complaint regarding Commission of Cognizable
Offenses: Criminal Trespass, Criminal Intimidation, Assault, and
Assault with Intent to Disrobe and Outrage the Modesty of a
Woman.

Respected Sir/Madam,

I, **Monika Roy**, Wife of Bablu Roy, resident of Khudiram Colony,
Ward No. 18, Subhaspally, under the jurisdiction of Siliguri Police
Station, do hereby lodge this written complaint to bring to your
immediate attention a heinous crime committed against me and my
family.

The facts of the incident are as follows:-

- 1. Legitimate Activity:** On Date-12/02/2026 at approximately
Time-5:00pm, my husband, along with hired laborers, was
peacefully conducting legitimate construction/renovation work
within the premises of our aforementioned residence. I was
present at the home, engaged in my domestic duties.
- 2. Criminal Trespass and Unlawful Assembly:** Suddenly, my
neighbor, one **Mukhtar Baitha**, accompanied by a group of
unidentified men and hired anti-social elements (miscreants),

unlawfully trespassed onto our property. They formed an unlawful assembly with the common intention to cause harm.

3. **Criminal Intimidation and Assault:** The accused persons immediately commenced a verbal altercation, using abusive and filthy language regarding the construction work. They proceeded to criminally intimidate us, issuing dire threats to our lives. Subsequently, acting in concert, they launched a brutal physical assault upon my husband, inflicting bodily harm.
4. **Sexual Assault and Outrage of Modesty (Crucial Facts):** When I rushed to the spot to rescue my husband and intervene, the prime accused, **Mukhtar Baitha**, directed his aggression towards me. He physically seized me by my hair and forcefully dragged me to the ground.
5. **Attempt to Disrobe:** In a brazen act of moral turpitude, while I was incapacitated on the ground, the accused Mukhtar Baitha assaulted me with criminal force. He forcibly inserted his hands inside my clothing, violating my bodily integrity. Furthermore, he tore my garments (upper/lower) with the **explicit and malicious intention to disrobe me legally and publicly**, thereby outraging my modesty in full public view.

Legal Submission: The acts committed by Mukhtar Baitha and his accomplices constitute serious cognizable and non-bailable offenses, including but not limited to:

- House Trespass.
- Voluntarily causing hurt.
- Criminal Intimidation.
- Assault or criminal force to woman with intent to outrage her modesty.
- Assault or use of criminal force to woman with intent to disrobe.

Given the traumatic nature of this sexual assault and the threat posed by these individuals to my family's safety, I earnestly request you to treat this letter as a formal **F.I.R.** I pray for immediate legal action against Mukhtar Baitha and his associates and request police protection for my family.
