Sub - Attempt to murder by Sumi Malakar Sarkar.

Sir,
With due regards, I, Nargis Chakraborty, wife of Late Pradip Kumar Chakraborty, resident of Balardas Chatterjee Road, Hakimpara, Siliguri, would like to state that my life is in risk and I am being terribly harassed by Swarnendu Tarafder and Sumi Malakar Sarkar for the last few months. I already had reported about it before but still facing the same. The person whom I was about to get married soon by the consent of both the families had cheated on me for the few years which I did not know. I got into a terrible trauma and was fully broken when I got to know that he had an affair with a married woman Sumi Malakar who had a daughter and husband. On knowing the truth, I declared an end to this relationship and stopped any kind of contact with Swarnendu Tarafder. But he continuously keep on disturbing me and forcing me to settle everything and told me to agree to marry him. I informed his parents and that lady but they harassed me and Sumi Malakar started threatening me. I did not want any kind of relation with any of them but they kept on disturbing me by coming to my house, calling me etc. I was alone and with the demise of my father I did not get the courage to take any action against them.

They both want me to marry him and as the lady is also married so she said that she has no problem if Swarnendu marries me and keep me as his wife, but she will still continue their relationship as it is.

But as a normal human being, it was never possible for me to agree to them so I wanted an end.

They still mentally harass me, embarrass me on the road, in front of my house as they know I can't shout or take any drastic action against them. I thought me to be a weak person and kept on harassing me every now and then.

On 14th February 2026, Swarendu came to my house and brought me the bouquet and the gifts for valentines day. I called his family again to say not to disturb me but they did not respond.

At around 9:15, that lady Swarendu's illicit girlfriend came to my house in a drunken condition and started banging the door. She kept on kicking on the door and shouted saying "Aaj shesh karke toke". I was extremely scared and called the number 100. Getting no response I called some of our known one's and when some people gathered, she ran away. She seemed to have something on her hand and she was very furious. She also broke the door bell and kept on kicking the door hard.

I feel she got very insecure about her relation with Swarendu and wants me to remove from their way & when I am not at all in his life from my side. The lady is very frustrated and I am scared of her.

My life is in danger and I don't feel safe to go out and have a normal life.

I earnestly request you to please
take the necessary action to do the
needful to save me and my family.
Please help me and get me out of this
harassment.
