and after some time the accused No - 1 has permanently shifted himself at the parental house of the petitioner Sahid Bhagat Singh Road, Natunpara, Jalpaimore, P.O - Siliguri Bazar, P.S - Siliguri, District - Darjeeling. 734005 as ghar Jamai.

3) That during his stay at his matrimonial house i.e. the parental house of the petitioner, the accused No - 1 has started alluring the parents of the petitioner for construction of a building upon the land of the parents of the petitioner and when they have agreed for the same, then he disclosed that as he has not so much fund and for the construction of a building, he has to obtain loan and accordingly he convinced them to donate some portion of their land in his name so that he can obtain loan from bank for the construction building and the parents of the petitioner have donated the land measuring about 0.0253 acres, out of which the land measuring about 0.0073 acres recorded in L.R Khatian No - 160/1 in part of Plot No- 2169/3647 and the land measuring about 0.008 acres recorded in L.R Khatian No - 160 part of Plot No - 2018 and the land measuring about 0.010 acres in L.R Khatian No - 160 part of Plot No - 2019, situated within Mouza - Siliguri, J.L. No - 110 (88), Paragana - Baikunthpur, P.S - Siliguri, District - Darjeeling by virtue of a registered deed of Gift dated 14 - 7 - 2014 and the said deed was duly registered in the office of ADSR, Siliguri, in Book No - 1, Volume No - 5, Page 3483 to 3496 Being No - 1413 for the year 2014 in the joint name of the petitioner and the accused No - 1.

4) That after such donation in the year 2017 the accused No - 1 and the petitioner has started constructing building and when the accused No - 1 and the petitioner have started suffering with financial crisis for the construction of the building in the month of January 2018 have approached the accused No - 2 for house building loan.

5) That after proper searching and after considering income of the accused No - 1 who is a Government school teacher and presently posted at Saktigarh Vidyapith, PWD More, Saktigarh, P.O - Siliguri Bazar, P.S - N.J.P, District - Jalpaiguri, 734005, the accused No - 2 with due consultation with the accused No - 2 agreed to sanction Housing Loan amounting to Rs. 17,30,000/- in favour of the accused No - 1 and the complainant with collateral security of land and building and accordingly on 9 - 1 - 2018 agreement for Housing Loan was executed in between the accused No - 2 with the accused No - 1 and the complainant.

That after such sanction of loan, the accused No - 1 has started paying the monthly installment of the loan to the bank on monthly basis and in the mean time the construction of the building was completed.

that during the enjoyment of building, in the month of March 2023 the accused No - 1 asked the complainant to visit bank with him on the pleading that as she is one of the borrower of the loan, a joint application is required to made before the bank to reduce the bank interest and accordingly she had been to accused No - 2 with the accused No - 1 and after reaching to accused No - 2, the accused No - 1 started showing his haste and asked to accused No - 2 to give paper for the signature of the complainant and accordingly, the accused No - 2 has placed one paper before the complainant and without giving any time to the complainant to go through the said paper asked her to sign on the paper and considering the haste of the accused No - 1, she put her signature on a single paper in the office of the accused No - 2 and soon after collection of her signature, the accused No - 1 asked the complainant to return and accordingly, both the accused No - 1 and the complainant returned back to their residence.

- 8) That after reaching house, your complainant again asked the accused No - 1 about the said paper and the accused again narrated the same fact that the said paper consists for the reduction of interest upon loan money and the complainant became sure that she signed the paper for reduction of interest upon the loan money.
- 9) That during the enjoyment of the building, the complainant noticed that the accused No - 1 has started maintaining extra marital relation with his maid servant and upon her objection, the dispute started arising in between them. In spite of that to save her marital life, your complainant by avoided such illegal act of the accused upon his assurance that he will not repeat his act in future and the said maid servant also assured the complainant that she will disconnect her relation with the accused No - 1.
- 10) That being a school teacher, the accused No - 1 used to give tuition to the student not only to his school's students but the students of other schools also in private manner in the residence.
- 11) That on 3 - 2 - 2024 when the complainant was out of house, the accused No - 1 has molested a minor female student aged about 13 years, resulting which on 4 - 2 - 2024 the parents of the victim girl alongwith local people made gherao of the house for the said illegal act of the accused No - 1 and at that time, your complainant first time came to know that the accused No - 1 has molested minor girl and accordingly, the parents of the victim girl lodged FIR against the accused No - 1 having Siliguri (W) P.S Case No - 10/2024 dated 5 - 2 - 2024 Under Section 8/12 of POCSO Act.
- 12) That when the accused No - 1 was in correctional home in relation with Siliguri (W) P.S Case No - 10/2024 dated 5 - 2 - 2024, in the month of March 2024, your complainant

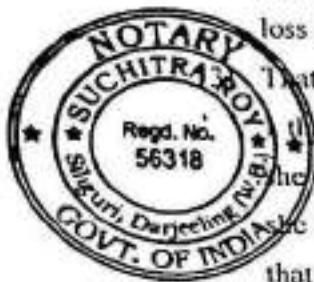

first time came to know that the accused No - 1 has TOP-UP the said housing loan with a sum of Rs. 10,00,000/- and after his release on bail, upon asking that when there is no need of further loan then why he had TOP - UP the Loan and when he TOP UP the said loan with the said money amounting to Rs. 10,00,000/- at that time the accused No - 1 has disclosed that in the month of March when both had been to bank for the reduction of interest at that time, the loan was TOP-UP. It is to be mention here that the accused No - 2 and 3 in collusion with the accused No - 1 has opened OD TOP-UP 319600990000834 without the knowledge and consent of the complainant to get illegal gain and wrongful loss to the complainant.



That on the said issue when the complainant raised her objection before the accused No - 1 that how can the bank TOP-UP the loan without the consent of the complainant when she is one of the borrower of the housing loan, the accused No - 1 disclosed that when she had been to bank in the month of March 2023 at that time she signed one paper and that paper was her consent form for the TOP-UP of the loan.

- 14) That after hearing the said fact, your complainant made contact with the accused No - 2 to stop to release the money of TOP-UP amount in favour of the accused No - 1 or in her favour and at that time the complainant came to know that the accused No - 1 has already withdrawn a sum of Rs. 4,00,000/- and there is a sum of Rs. 6,00,0000/- only.
- 15) That upon the request of the complainant, the accused No - 2 stopped to release the further fund of TOP-UP of loan money.
- 16) That since the said illegal act of the accused No - 1, with the said Minor girl, and on the issue of TOP-UP of loan money which the accused No - 1 has obtained in collusion with the accused No - 2, and 3 to cheat the complainant, the relation in between the accused No - 1 and the complainant became strange and lastly the accused No - 1 by leaving the complainant has left the house and has shifted somewhere in rented house and continued his job in his school.
- 17) That the accused No - 1 not only withdrawn himself from the marital relation with the complainant but on and from the month of September 2024 the accused No -1 has completely stopped to pay the monthly installment of the housing loan to the accused No - 2.
- 18) That the accused No - 1 is a very shoot mind man and he know how to manage the officials and by his behavior he used to get success to maintain relation with any body and he also made a very good relation with the bank officials i.e. the accuse No - 2 and 3

and by taking advantage of his relation he managed to get TOP-UP the loan to cheat the complainant as per his preplanned thought.
That soon after his desertion to the complainant, though the accused No - 1 has cleared the monthly installment for the month of September 2024, inspite of that upon the investigations of the accused No - 1, the accused No - 2 has started demanding he monthly installment for the month of September 2024 from the complainant and the accused No - 2 not only visiting to the residential address of the complainant but also started visiting the complainant for the monthly installment for the month of September 2024 on the pleading that the accused No - 1 denied to make payment of the installments.



- 20) That inspite of repeated disclouser of the complainant that the accused No - 1 is not residing with her and he will be available at Saktigarh Vidyapith, PWD More, Saktigarh, P.O - Siliguri Bazar, P.S - njp, Dist - Jalpaiguri at his school, the accused No - 2 and 3 have never took any step to made contact with the accused No - 1.
- 21) That when the mental torture of the accused persons became unbearable, on 29 - 10 - 2024 your Complainant made advocate notice o the accused No - 2 and 3 and others and in response of the said advocate notice, the accused No - 1 made his reply on 13 - 11 - 2024. Be it mention here that though the bank is well aware that after considering the salary of the accused No - 1, it has sanctioned loan inspite of that the accused No - 2 has not issued the notice to the accused No - 1 which clearly shows the male trade practice of the accused No - 2 and 3.
- 22) That after receiving the notice of the complainant the accused No- 2 and 3 in collusion with the accused No - 1 have instead of making demand of loan installment from the accused No - 1 have started disturbing the complainant for the re-payment of the loan money and whenever your complainant asked them to ask for installment money from the accused No - 1, they used to say that they are not concerned with him save and accept with the loan installment money.
- 23) That after receiving the said advocate Notice, the accused No - 2 and 3 became more aggressive against the complainant and have started threatening her if the loan money be not re-paid, they will auction the property and upon their every communication, your complainant has made reply and asked and requested them to issue such notice to the accused No - 1 at his official address i.e. Saktigarh Vidyapith, PWD More, Saktigarh, Siliguri Bazar, P.S - njp, Dist - Jalpaiguri, instead of her address but the accused No - 2, and 3 always remain silent upon the said issue. The conduct of the accused No - 2 and 3 clearly shows that they are acting just upon the instructions of the accused No - 1.

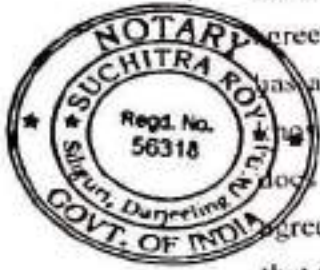
24) That the accused No - 2, and 3 have never tried to recover the loan money from the accused No - 1 though they are well acquainted with the fact that after considering his salary, the loan was disbursed and the complainant has no capacity to re-pay the loan. Though the accused No - 2 has every liberty to recover the loan money from the salary of the accused No - 1 but they did never taken initiative to adopt the process of recovery of loan from salary of the accused No - 1

25) That during such communication and sittings with the accused No - 2, your complainant came to know that for the obtaining of OD TOP-UP, several documents alongwith agreement (Master Agreement) was executed on 25 - 3 - 2023 where the complainant was also signed but after going through the said documents, your complainant came to know that though there is a signature in the name of complainant but the said signature does not belongs to complainant. Your complainant did never sign any documents or agreement for OD TOP-UP. From the said signature, your complainant came to know that the accused No - 1 in collusions with the accused No - 2 and 3 have manufactured her signature and on the basis of such fake signature of the complainant, the accused No - 2 and 3 have TOP UP the loan with a sum of Rs. 10,00,000/- to cheat the complainant. The accused No - 1 in collusion with the accused No - 2 and 3 have defrauded the complainant in the name of OD TOP-UP of loan with a sum of Rs. 10,00,000/- out of which the accused No - 1 has all ready withdrawn a sum of Rs. 4,00,000/- and thus the accused No - 1, 2 and 3 have cheated the complainant with the um of Rs. 4,00,000/-.

Be it mention here that your complainant repeatedly asked and requested the accused No - 2 and 3 through E mail and letter to investigate the matter and take necessary legal action against the accused No - 1 who with intention to defraud the complainant has signed a fake signature of the complainant in collusion with the accused No 2 and 3.

26) That from the conduct of the accused No - 1 it is crystal clear that from the very beginning, his intention was to cheat the complainant and with the help of the accused No - 2 and 3 has managed to misappropriate public money in the name of TOP-UP of loan and now the accused No - 1 has denied to re-pay the loan money.

27) After having information, that the accused No - 2 and 3 have released a sum of Rs. 10,00,000/- in the name of TOP-UP of loan, based on fake signature of the complainant,

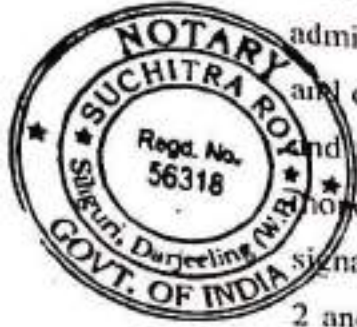

- complainant had been to Siliguri Police Station several times to lodge her complaint but, on each and every occasions the Police Officials of Siliguri Police Station refused to receive the complaint for the reason best known to them.
- 28) That even your complainant has also asked the accused No - 2 and 3 to make enquiry how the OD TOP-UP was released when the complainant has not signed any documents or has not given her any consent for TOP-UP of loan but the accused No - 2 and 3 always remained silent on the issue to protect the accused No - 1 and their officials.
- 29) That lastly on 8 - 7 - 2025, your complainant has again made an attempt to lodge her FIR but the police officials have denied to receive the FIR, finding no other alternative on 10 - 7 - 2025 your complainant made her complaint before the Commissioner of Police but with no result.
- 30) That on the same day i.e. 10 - 7 - 2025 your complainant has also made complaint to the accused No - 2 and upon her said complaint, the authorized signatories of the accused No - 2 and 3 made reply on 22 - 7 - 2025 by denying the allegation of the complainant and have avoided to make any averment upon the issue of TOP-UP of loan.
- 31) That the accused No - 1 is a very influential person having deep relation with administration and Govt. officials and having money power and very criminal minded and dangerous in nature and the accused No - 2 and 3 are the custodian of public money and they have in collusions with the accused No - 1 have misappropriated the public money in the name of releasing of fund on the head of OD TOP-UP based on fake signature of the complainant and they no regard in law not only that the accused No - 1, 2 and 3 in collusion with each other have cheated the complainant in the name of OD TOP-UP of the loan and the accused No - 1 has misappropriated the sum of Rs. 4,00,000/- out of the total TOP-UP of loan of Rs. 10,00,000/-
- 32) That the incident took place within the jurisdiction of the Ld. Court as such the Ld. Court has every jurisdiction to try the case.
- 33) That the application is made bonafide for the ends of justice.

Under the above facts and circumstances, it is therefore prayed that your honour would graciously be pleased to pass necessary order under section 175 (3) of B.N.S.S, directing the Inspector - In - Charge, Siliguri Police Station, District-Darjeeling to investigate into the matter and start a specific case against the accused person and further be please to pass such other order / orders as your Honour may deem fit and proper.
