Subject: Request of registration of FIR regarding theft of gold and silver jewellery from my home

Sir,

I Deep Kumar Sharma s/o Shri Sikandar Sharma presently residing at Vivekananda Nagar ward No. 42, near Health Centre P.S. Bhakti Nagar District Jalpaiguri most respectfully submit as under that certain gold and silver jewellery items belonging to my wife were kept securely inside a locker placed within the almirah of my bedroom at the above mentioned address.

The said jewellery items were last kept safely and locked inside the locker after use on the occasion of Saraswati Puja on 23/1/26.

On 15/2/26 on the occasion of Mahashiv ratri between 6:00 AM and 6:30 AM when my wife opened the almirah and attempted to open the locker, she found that the locker was already unlocked and the key was found inserted in the keyhole.

That there was no authority or consent given by me to any person apart from wife to open the said locker. The circumstances clearly indicate a case of theft in my house.

The stolen items include 1 gold Mangal sutra, 2 gold bangles, 2ps Mang tika, 2 Nath, 3ps Gold ring, 4 ear rings of gold, 6 gold nose pin, 20ps silver payal, 1 silver Kamar Darkus, 8ps silver bichiya, 1 silver sindur kiya, 1 silver baju bandh, 1 silver bracelet which were in two pink bags.

I therefore request you to kindly register an FIR under appropriate sections of law and please take necessary steps for recovery of the stolen items.
