Sir,

I, ASI Dipak Karmakar of Bhaktinagar P.S. Siliguri Police Commissionerate, do hereby lodged this written complaint against the arrested accused persons namely; (1) Rajen Pandit @ Chattu (23 yrs) S/O Raju Pandit of Gourangapally, Dakshin Ektiasal, Ward No. 40, PS- Bhaktinagar, Dist- Jalpaiguri (2) Md Bipul Islam @ Md Rabiul Aoyal (34 yrs) S/O late Belal Hossain of Vivekananda Nagar near Masjid, Ward No. 42, PS- Bhaktinagar, Dist- Jalpaiguri, (3) Vasha Raj Bangshi @ Nedu (22 yrs) S/O Ujjal Raj Bangshi of Adarshapally near Bandhan Bank, PS- Bhorer Alo, Dist- Jalpaiguri and (4) Arun Chhetri (48 yrs) S/O Chandra Bahadur Chhetri of Salugara Bazar near Durga Mandir, Ward No. 42, PS- Bhaktinagar, Dist- Jalpaiguri under arrest along with following seizure articles; (i) One steel made knife with wooden handle measuring approx 10.10 inches , recovered from the possession of Rajen Pandit @ Chattu (which was on his hand) (ii) One Iron made Sickle with wooden handle measuring 9 Inches , recovered from the possession of) Md Bipul Islam @ Md Rabiul Aoyal (it was on his hand) (iii) One Iron made Plus having two handles measuring approx 07 Inches , recovered from the possession of Vasha Raj Bangshi @ Nedu and (4) One iron made Range measuring approx 07 inches (it was on his hand) , In this regard, I beg to report that on 19.02.26 at 00.10 hrs received secret reliable source information that about 11/12 anti socials being armed with deadly weapons assembled at P.C Mittal Bus Stand, ward no. 43 under Bhaktinagar PS for making preparation to commit dacoity in a house at lower Bhanunagar area under Bhaktinagar PS. I informed this source information to I/C Bhaktinagar PS and noted the information vide Bhaktingar PS GDE No. 968 Dated 19.02.26. As per the direction of I/C Bhaktinagar PS, at 00.15 hrs, I along with ASI Khagen Barman, ASI Dhruva Mishra, SI Abir Dhar, C/828 Dulal Barman, C/1427 Swapan Roy, C/374 Debraj Biswas along with investigation Kids left for P. C Mittal Bus Stand, ward no. 43 under Bhaktinagar PS for working out the information vide Bhaktinagar GDE No. 969 Dated 19.02.26 after briefing officers and force properly. At 00.25 around hrs we reached at P. C Mittal Bus Stand, ward no. 43 under Bhaktinagar PS and kept our vehicle at considerable distance P. C Mittal Bus Stand , ward no. 43 under Bhaktinagar PS. Then, I along with other Officers and force headed towards P. C Mittal Bus Stand , ward no. 43 under Bhaktinagar PS looking for witnesses, if any on the way and found nothing. By this time we reached at P. C Mittal Bus Stand , ward no. 43 under Bhaktinagar PS, as Informed by secret source, we could see a group of persons standing and were whispering in subduded suspicious manner. On seeing us, they tried to flee away but somehow, above noted four persons could be apprehended and detained them. Then, after disclosing our identity, I asked them their motive to assemble at such a place and in such odd hours of night and in such a

suspicious manner. On being asked they disclosed their names and address as noted above and admitted that they along with 07/08 others assembled at the spot making preparation to commit dacoity tonight in a house at Lower Bhanunagar area under Bhaktinagar PS. I accordingly searched them in presence of witnesses and found (i) One steel made knife with wooden handle measuring approx 10.10 inches , recovered from the possession of Rajen Pandit @ Chattu (which was on his hand) (ii) One Iron made Sickle with wooden handle measuring 9 Inches , recovered from the possession of) Md Bipul Islam @ Md Rabiul Aoyal (it was on his hand) iii) One Iron mada Plus having two handles measuring approx 07 Inches , recovered from the possession of Vasha Raj Bangshi @ Nedu and (4) One iron made Range measuring approx 07 inches (it was on his hand) were making preparation for committing Dacoity tonight in a house at Lower Bhanu Nagar area under Bhanunagar PS but others managed to escape from the spot. Accordingly, I seized above noted weapons in presence of witnesses under proper seizure list duly signed by them and arrested them informing them their ground of arrest preparing memo of arrest. The seizure was made in between 00.45 hrs and 01.30 hrs dated 19.02.26. The whole search, seizure were made under Videography. On further interrogation the arrested accused persons also confessed that they along with others assembled at the spot for making preparation to commit Dacoity tonight in a house at Lower Bhanu Nagar area, but others managed to escape from the spot.

From the above noted facts, seizure and circumstance there is reason to believe that accused persons had assembled there with deadly weapons making preparation to commit dacoity in a house at Lower Bhanu Nagar area under Bhaktingar PS.

Further, it is to mention here that the arrested accused persons are well known anti social and have been indulged in many criminal cases.

Therefore, I pray before you to start a specific case against the above noted arrested accused persons and others 07/08 others who fled away, under proper section of law and to cause its investigation.
