Sir,

With due respect and humble submission after producing one (01) arrested accused person Kolin Roy (M/60) s/o Late Palandu Roy of Sardar Para, PO Sahudangi Hat, PS Bhorer Alo, Dist. Jalpaiguri and seized articles I, SI Sailesh Subba of Bhorer Alo P.S, SPC would like to lodge this written complaint to the effect that today on 18.02.2026 at about 18.15 hours while performing evening raid duty vide Bhorer Alo PS GDE No. 674, Dated 18.02.2026 received a source information that one person had stored huge quantity of liquor his tea shop situated at Canal More under Bhorer Alo PS and is selling illegally. The matter was informed to Officer-In-Charge, Bhorer Alo PS over phone and as per his kind order myself along with ASI Utpal Das, C-1492 Partha Chakraborty, C-1489 Samir Barman of Bhorer Alo PS left towards Canal More to verify the information received.

At about 18.25 hours I, along with force reached at Canal More and being identified by the source, I along with force conduct raid at the shop of said Kolin Roy and apprehended him. On interrogation he disclosed his name as noted above and confessed for storing liquor for selling to his customers for his wrongful gain since long. Thereafter I, along with my accompanied team searched his shop and recovered "Thirteen (13) sealed bottles of Himalayan Gold, India Made Liquor, 60 UP, each bottle containing 600 ml when packed". On demand he failed to produce any documents or license for possessing and selling the liquor in his shop.

During enquiry it could be learnt that he has been involved in selling and possessing of illicit liquor in his shop without any valid license since long for his illegal gain. Hence, I prepared seizure list and label of the above recovered liquor in presence of witnesses after observing all sorts of formalities and arrested the apprehended accused person after appraising him the ground of arrest for violating norms of Bengal Excise Act. The whole process of seizure was made in between 18.36 hours to 18.45 hours under videography on esakhya portal.

Under the above noted fact and circumstances I, pray before your good self that a specific case under proper section of law may kindly be initiated against arrested accused person namely Kolin Roy (M/60) s/o Late Palandu Roy of Sardar Para, P.O Sahudangi Hat, P.S Bhorer Alo, Dist. Jalpaiguri and may arrange to cause its investigation under proper section of law.
