Nagar, Near Fuleswarai Rail Gate, Siliguri, Darjaling.

I am legally married to Mr. Achintya Dutta, S/O Late

Arijun Dutta, residing at 316/B Samresh Bosh Sarani,
Mitrapally, Beside R.B.S Club, Siliguri, Darjaling, Pin NO: 734005

P.O. Siliguri Bazar (Occupation: Family Business) since
22th of May 2015.

Due to his continuous mental, physical harass-
ment and misconduct, I am compelled to submit the
application.

I would like to state that my husband is
involved in a extramarital affair with Mrs. Priya Bal from
last 4/5 year who is presently w/o Mr. Janmay Bal
residing at Khatol Tala, Siliguri and previously was w/o Mr.
Nabin Saha. This extra marital affy affair has
caused me several mental and physical trauma

physical harassment and humiliation. When ever me and my family tried to make him understand and resolve the matter peacefully, he would become aggressive, as result of his aggression he would often use abusive language towards me and my parents. This has caused me immense mental pain and agony. On several occasion he has intentionally inflicted physical pain upon me with the object of intimidating and dominating me. This has also resulted in added mental stress and psychological distress to me.

Due to his constant harassment, abusive behavior and intolerable mental torture I was forced to leave my matrimonial home and currently I am residing at my parental house for my and my daughter's safety [Ahana Datta, Age - 8+ (Eight), studying in class III at Nirmala Convent School, Siliguri] safety.

Further, he is not providing adequate financial support for me and our daughter, he is not bearing expenses related to food, daily necessities, medical needs or other essential expenditures. The monetary support presently being provided by my husband is insufficient for the maintenance and basic needs of me and our minor daughter, and my husband is threatening me to withdraw the paid bare minimum financial support.

Previously on several occasion my husband had coerced and compelled me to obtain and transfer money from my father for purpose of his business and in the event of denial he would verbally abuse and

harass me.

He would frequently call me during my office hours and use abusive and derogatory language, causing disturbance in my professional life and further mental harassment, even after blocking my husband's phone number he so persistently harassed me by making repeated calls from several unknown numbers.

Even after all these things, I would like to mention that last night, while I was picking up my daughter from her tuition which is at Vinodkan Garden, Children Park, Milanpally, Siliguri, during my husband suddenly appeared and physically attacked me. He also penetrated my scooter to harass me. Both I and my daughter were extremely nervous, so I called the police for help.

The above-mentioned acts have caused me severe emotional distress and made my life very difficult. Therefore I humbly request you to kindly record this matter and take necessary steps as per law ~~of~~ to ensure me & my daughter's safety and well-being.
