Sir,

In producing herewith following three arrested persons namely 1) Iptarul (26 years) S/O Ajmal Ali of Bahatigachh, PO Kuchila, Kamalanagar, PS Islampur, Dist Uttar Dinajpur. 2) Ram kumar Mandal (38 years) S/O Jaibir Mandal of lower Bhanunagar, near Shiv Mandhir, ward no 40, PS Bhaktinagar, Dist Jalpaiguri and Jahedullah Momin (36 years) S/O Kabatullah Momin of Chandpur Mominpara, PO Jalapur, PS Kaliachok, Dist Malda along with the following seized articles under seizure as per seizure list:

- 1) One transparent plastic zipper bag containing 451 grams said to be brown sugar marked as exhibit "A".
- 2) One brown colour ply wood box marked as exhibit "B".
- 3) Indian Currency total value under following denomination Rs 500x31= 15,500/-, 200x3=600/-, 100x3=300 and 50x69= 3450 in total 19,850/- which was kept in a left pocket of his jeans pant marked as exhibit "C".
- 4) One navy colour back pack style as HP marked as exhibit "D".
- 5) One Samsung android mobile phone having IMEI no 344324784159812/01, 356205204159813/01 recovered from the possession of Ram Kr Mandal marked as exhibit "E".
- 6) One Oppo android mobile phone having IMEI no 866830045737833 & 866830045737825 recovered from the possession of Jahidula marked as exhibit "F".
- 7) One vivo android mobile phone having IMEI no 862722085413231 & 862722085413223 marked as exhibit "G".
- 8) One KTM motorcycle Green & Orange colour having registration no SK07P 0382 marked as exhibit "H"

Note: Exhibit A was kept and concealed in exhibit "B", Exhibit A & B were kept in exhibit "D" Motorcycle was being riding by Iptarul and carrying a navy blue backpack, along with another two male persons who were riding as the pillion rider.

I, SI Youel Lepcha, S/O Jai Tshering Lepcha, of Bhaktinagar PS under Siliguri Police Commissionerate, hereby submit this written complaint against the above-mentioned accused person. On 19.02.2026, at about 15.05 hours, I received reliable information indicating that three individual coming from Champasari area on a duke motor cycle who are believed to be in possession of a Narcotic substance. This information was recorded in the Bhaktinagar PS diary as GDE No. 996/26 dated 19.02.2026. Following this, I informed the matter in writing to the In-Charge of Bhaktinagar PS. Upon receiving directives, at around 15.20 hours, I, along with ASI Dhurbo Mishra, ASI Dipak Karmakar, ASI Khagen Barman and Constable 374 Debraj Biswas, departed from the police station in a government-hired vehicle to verify the validity of the information. This refers to Bhaktinagar PS GDE no. 997/26 dated 19.02.2026 and M.C.C No- 658/26 dated 19.02.2026

Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

As per the order of the In-Charge of the Police Station, I called K 37 ASI Ratan Sarkar along with force to accompany us in pursuing this information. At approximately 15:35 hours, we arrived at National Highway 10 in front of Indira Gandhi Maidan under Bhaktinagar PS.

After arriving there and i shared the information we had and convinced the available public who were present at that time, following two persons came forward to accompany us for conducting search & Seizure if required, the details of individuals are 1) Rahul Mandal (29 years) S/O It Goutam Mandal of upper Bhanu nagar, behind Cosmos mail, PS Bhaktinagar, Dist Jalpaiguri and 2) Varun Singh (24 years) S/O Lt Raju Singh of Prakash nagar near sporting club, PS Bhaktinagar, Dist Jalpaiguri and requested, in writing, They provided written approval to join the police during the raid and began naka checking at the spot.

Acting upon a credible tip-off, a green and orange motorcycle bearing Registration No. SK-07-P-0382 was intercepted and detained. The motorcycle was being riding by one individual carrying a navy blue backpack, along with another two male persons who were riding as the pillion rider.

We identified ourselves and provided the information we had, explaining that the individuals would be searched. They disclosed their name and address as noted above.

They admitted that they were in possession of brown sugar, intending to supply it to their designated customers as needed. I then offered them the option to be searched in the presence of a Special Executive Magistrate or by a Gazetted Officer. They agreed to be searched by one of them.

Subsequently, I issued a notice in accordance with legal provisions regarding the matter. I sent a written requisition to Shri Amit Adhikary, Inspector In-Charge of Bhaktinagar Police Station, requesting him to come at National Highway 10, in front of Gandhi Maidan under the jurisdiction of Bhaktinagar PS to supervise a search and seizure operation.

At about 18:05 hours, Shri Amit Adhikari arrived at the spot as the Gazetted Police Officer. Subsequently, under his supervision and in the presence of witnesses, a thorough search of the detained individuals and the backpack carried by Iptarul (who was riding the motorcycle) was conducted. During the search, the aforementioned articles marked as Exhibit A & B were recovered from the navy blue backpack, along with cash amounting to ₹19,850/- (Rupees Nineteen Thousand Eight Hundred Fifty only), which was found in his left jeans pocket.

Further being demanded in presence of Shri Amit Adhikary Inspector In-Charge, Gazette Police Officer the detained persons failed to produce any valid document in support of aforesaid recovered brown sugar.

I measured the recovered brown sugar in a weighing machine and seized all the recovered articles at the spot under proper seizure list duly signed by the independent witnesses, I also labeled and sealed the same, the entire search and Seizure was conducted under the supervision of Shri Amit Adhikary, Inspector In-Charge of Bhaktinagar PS. The whole process of search & seizure had been captured in audio & video records. The whole process of seizure was made on 19.02.2026 between 18.25hrs to 20.05 hrs.

Being further asked, the apprehended persons admitted in presence of Shri Amit Adhikary, Inspector In-Charge of Bhaktinagar PS and other witnesses that they procured the brown sugar clandestinely from elsewhere for the purpose of selling the same in high rate to his designed customer for their personal gain by illegal means also disclosed that they have been dealing in such business of procuring and selling of brown sugar illegally for last few months.

Then, I arrested the above noted accused persons namely 1) Iptarul 2) Ram kumar Mandal and 3) Jahedullah Momin after observing all formalities and informing the ground of their arrest and issued a necessary Memo of Arrest u/s 35 of BNSS.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused person namely 1) Iptarul 2) Ram Kumar Mandal and 3) Jahedullah Momin and arrange for its investigation.
