PO & PS Pradhan Nagar) was staying with my father
who forcibly kept me with him since I was 8
years of age. Initially I was given good treatment
and pampering because I refused to go to my
mother who was working as a Professor in
Katkhar Medical College, Katkhar under the
impression that Katkhar is a remote area and
a village. I was taught by my father not
to go with my mother and also to my
grandparents subject to which I was
strictly instructed to disconnect and not
to meet my mother. Gradually my father
started HITTING me after drinking and
was not allowed to go to school. After
remarrying my father severely tortured
me; did not give me food to eat
and punched on my head. So I
have decided to go back to my mother
and I want to stay permanently with
her. Thanking you.

Since then he has increased his level of torture both physically and mentally. Now I am again studying in class 8 (DPS, dapper sibiru) and I wish to stay with my mother. Necessary legal action be taken against my father so that he can't torture me and keep me with him forcefully.
