Sir,

With due respect, I Subhas Barai S/O Lakshman Barai resident of Khidirpur Purbapara, PO- Bethuadahari, PS- Nakashipara, Dist. Nadia, Pin- 741126 would like to inform you that, I am the In-Charge of Delivering Dreamz DLLP having its office at Narmada Bagan, near Alahadab Bank, Champasari, PS- Pradhan Nagar, Dist. Darjeeling. Our company works on E/Comers-E/logestic and Courier service with Flipkart. We have a godwn at the above mention address at Narmada Bagan, near Alahadab Bank, PS- Pradhan Nagar, and Dist. Darjeeling. On 17.02.26 at around 11.45 PM we closed our Godwn and all the staff left the Godwn. On 18.02.26 at around 06.45 am I came to the Godwn and found the back side window of our Godwn is broken. After entering the Godwn I found all the articles kept inside the Godwn were scattered. Thereafter, I along with others staff of the company matched the stock register with the physical stock and ininitially found following 15 numbers of new box containing delivery mobile phone are missing from the godwn.

I further like to inform you that the approx value of the above mentioned 15 stolen mobile phones are Rs 7,00,000/- (Seven lac) to Rs 8,00,000/- (eight lac). I strongly, suspect that on the last night unknown miscreants entered into our godwn by breaking the window of the godwn and stolen all the above mentioned mobile phones from the godwn. Hence, I request to your good office that kindly register FIR over this issue and kindly recover all the stolen mobile phones at earliest and to arrest the culprits and obliged thereby.
