Sir,

With due respect, I am producing herewith one (01) accused person namely Gobind Kumar Prasad (26 yrs) S/O Bikarma Sha of Teleha, Gopalpur Tola, PO - Pandit Rampur, PS- Bhagawanpur, Dist. Siwan, Bihar under arrest and the following articles under proper seizure list viz :- one red colour Trolley bag containing 21 (twenty one) bottles of bottle of "BLUE MOUNTAIN" Premium Grain Whisky each bottle containing 750 ml i.e, total (21 x 750 ml = 15.750 ltrs) for sale in Sikkim only and marked as "Exhibit A" - out of which one bottle of the same taken as sample for examination and Marked as Exhibit A-1". I ASI Biplab Kr Das of Pradhan Nagar PS, SPC do hereby lodged this written complaint against the above mentioned arrested accused person namely Gobind Kumar Prasad (26 yrs) S/O Bikarma Sha of Teleha, Gopalpur Tola, PS- Pandit Rampur, PS- Bhagawanpur, Dist. Siwan, Bihar to the effect that on 18.02.2026 at about 18.45 hrs I received specific secret information that one person carrying and possessing a huge quantity of illicit liquor without any documents was standing at Siliguri Junction in front of SJDA building under PS- Pradhan Nagar, Dist. Darjeeling and waiting there for a Bihar bound bus to sale the same in Bihar for his wrongful gain. Accordingly, I diarized the matter in PS General Diary of Pradhan Nagar P.S. vide GDE No. 1131 dated 18.02.2026, and the matter was intimated to you. As per your kind order and direction, I along with force proceeded to the spot by government vehicle with investigation kit to verify the veracity of the information.

At about 19.15 hrs we reached at Siliguri Junction and contacted with my source. Being pointed by the source we noticed that one person was standing with a red colour trolley bag in his possession at in front of SJDA building, Siliguri Junction. Accordingly, we cordoned the place from every corner and managed to detain the said suspect with a red colour trolley bag in his possession. Then we disclosed our identity as police personnel. On interrogation he disclosed his identity as noted above and on further interrogation he admitted his guilt and disclosed that he is carrying illegal illicit liquor in his bag and waiting there for a Bihar bound bus to go to Bihar to sale the same in Bihar for his wrongful gain. On search the trolley bag under the possession of the above mentioned detained person namely Gobind Kumar Prasad (26 yrs) S/O Bikarma Sha of Teleha, Gopalpur Tola, PO - Pandit Rampur, PS- Bhagawanpur, Dist. Siwan, Bihar recovered the above mentioned articles. On demand the said detain person failed to produce any valid licence or documents in respect of above mentioned illicit liquor recovered from his possession. Accordingly, I seized above noted articles under proper seizure list in presence of independent witnesses. The entire process of search and seizure was made in between 19.50 hrs to 20.25 hrs on 18.02.26 under the coverage of videography executed by Somnath Chatterjee, S/O Sushil Chatterjee of Arabinda Pally, Gokhel Road, Ward No 22, PS- Siliguri, Dist. Darjeeling as per the norms of BNSS and subsequently I arrested the said detain person namely Gobind Kumar Prasad (26 yrs) S/O Bikarma Sha of Teleha, Gopalpur Tola, PO - Pandit Rampur, PS- Bhagawanpur, Dist. Siwan, Bihar under proper memo of arrest and observing all the formalities for violating the norms of Bengal Excise Act and brought to Pradhan Nagar PS for further investigation. I also inform him regarding ground of his arrest in written.

Therefore, I pray before your good self that a specific case may kindly be initiated against the arrested accused person namely Gobind Kumar Prasad (26 yrs) S/O Bikarma Sha of Teleha, Gopalpur Tola, PO - Pandit Rampur, PS- Bhagawanpur, Dist. Siwan, Bihar under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
