Sir,

In producing herewith one (01) arrested accused person namely Naresh Kamti (38 yrs) S/O Promod Kamti of Rajendra Nagar, Coolipara, Ward No-01, SMC, PS- Pradhan Nagar, Dist. Darjeeling under arrest along with the following seizure articles viz :- (i) one (01) brown Colour cartoon Containing 40 (forty) sealed bottles of Codeine Phosphate & Triprolidine Hydrochloride Syrup cough syrup " REXLEY-T" each bottle containing 100 ml. i.e total (40 X 100 ml= 4000 ml) having batch No MLS26008, Mfg date 01/26, Exp date 12/27, MRP Rs 180.00/- each - Marked as Exhibit- "A" (ii) one maroon colour Scooty having Registration No WB-74-BA-6892 along with key "HONDA GRAZIA" - Marked as Exhibit "B" and (iii) one android Mobile phone blue colour styled as Redmi having IMEI No 864712058320271/864712058320289, Mobile No-9170291120337- Marked as Exhibit "C". I, SI Debabrata Khan S/O Late Probodh Kr Khan of Pradhan Nagar PS, Siliguri Police Commissionerate do hereby lodged this written complaint against the above noted arrested accused person namely Naresh Kamti (38 yrs) S/O Promod Kamti of Rajendra Nagar, Coolipara, Ward No-01, SMC, PS- Pradhan Nagar, Dist. Darjeeling to the effect that on 18.02.2026 at 22.15 hrs I received a reliable specific secret source input that one person would be come to Circuit House More, Champasari under PS - Pradhan Nagar, Dist. Darjeeling from Darjeeling More side by a scooty having Registraton No WB-74-BA-6892 with huge quantity of illegal Cough Syrup in his possession to delivery the same to his design customer. Accordingly, the matter was diarized in PS General Diary vide Pradhan Nagar PS GDE No. 1147 dated 18.02.2026 and I informed to you in writing. Subsequently, being directed by you at about 22.20 hrs myself along with ASI Biplab Kr Dás, ASI Prabal Sarkar, ASI Bikash Roy and others force of Pradhan Nagar PS, SPC left for Circuit House More, Champasari under PS Pradhan Nagar, Dist. Darjeeling without any search warrant or authorization for search which could not be possible to obtain from a competent authority for sudden development of such a sensitive information and also for not giving him opportunity for concealment of evidence or facility for his escape. This refers to Pradhan Nagar PS GDE No. 1148 dated 18.02.2026 and M.C.C. No. 298/26 dated 18.02.2026. I also informed one Videographer namely Somnath Chatterjee S/O Sushil Chatterjee of Santi Nagar, Boubazar, Ashighar, PS- Bhakti Nagar, Dist. Jalpaiguri over telephone and requested him to come to Circuit House More, Champasari under PS Pradhan Nagar, Dist. Darjeeling with his video camera for the purpose of video graphs if required. On the way, I briefed all the Police personnel properly sharing them the nature of information in hand. I also contact with RT Van officer SI Ribam Lepcha and share the information with him and directed him to come to Circuit House More, Champasari to accompany as well assist us.

At around 22.35 hrs we arrived at Opposite Circuit House, Champasari under PS- Pradhan Nagar, Dist. Darjeeling and contacted with my source while he informed that the person who possessing cough syrup will come to Circuit House More, Champasari shortly to deliver the same to his customers of Kalimpong. Then, I contacted with two available independent persons namely (i) Raja Sahani (26 yrs), S/O Chunchun Sahani of Reajendra Nagar, Coolipara, Ward No. 01, PS- Pradhan Nagar, Dist. Darjeeling and (ii) Pravin Kumar (21 yrs) S/O Upindar Mallick of of Reajendra Nagar, Coolipara, Ward No. 01, PS- Pradhan Nagar, Dist. Darjeeling and shared the information with them and requested them to remain present at the spot and act as independent witness if any search and seizure would be made upon which they agreed and expressed their willingness to co operate with me as well as to act witness. I also issued notice upon the above mentioned two independent witnesses. In the mean time RT mobile officers SI Ribam Lepcha along with force came to the spot at Opposite Circuit House, Champasari to assist us. There after, I again contacted my source who stated that the suspect carrying illegal cough syrup will come shortly from Darjeeling More side through NH 10 by a scooty having Registration number WB-74-BA-6892 to deliver the same to his designated customers at Circuit House More, Champasari. Then we started NAKA checking on NH-10 at Circuit House More, Champasari with due care and caution. At around 23.05 hrs we stopped one scooty having Registration No WB-74-BA-6892 at the said Naka point and detained the rider of the scooty. On search the scooty one paper made cartoon was found on the leg passage of the scooty. Thereafter, we disclosed our identities as Police personnel (as 4/5 police personnel were in civil dress for our convenience) and informed him regarding the information in hand. On interrogation, the detained person disclosed his identity as Naresh Kamti (38 yrs) S/O Promod Kamti of Rajendra Nagar, Coolipara, Ward No-01, SMC, PS- Pradhan Nagar, Dist. Darjeeling and also disclosed that he is carrying 40 bottles of cough syrup inside the carton in his possession and came there to deliver the same to his designated customer. Then, I issued notice in writing to him whether he wanted to search the paper made cartoon in his possession in presence of an Executive Magistrate or any Gazetted Officer as per norms of u/s 50 of NDPS Act, upon which he agreed to be searched in presence of any of the above noted officers.

Accordingly, I informed the matter to you over mobile phone and requested you to arrange an executive Magistrate or Gazetted Officer to supervise the entire process of search and if required seizure. At around 23.15 hrs on 18.02.26 the above named videographer arrived at Opposite Circuit House More, Champasari with his camera. Accordingly, I served a notice to him for videograph the entire process of search and seizure if required. Further at around 23.25 hrs on 18.02.26 you arrived at the spot at Opposite Circuit House More, Champasari under PS- Pradhan Nagar, Dist- Darjeeling to perform the duty of gazetted officer being the I/C of Pradhan Nagar PS and informed me that due odd hours of night no Executive Magistrate was available and as a gazetted officer you are legally authorised to give order to search the cartoon under the possession of the suspect.

Then, I served a notice to you to supervise the entire process of search and if required of seizure. Thereafter on camera, I offered both the independent witnesses noted above and the detained person to search our Police Personnel as per provisions of law but they denied searching the Police personnel. Then, in presence of you and independent witnesses noted above, I searched the brown colour cartoon under the possession of above mentioned detained person namely Naresh Kamti (38 yrs) S/O Promod Kamti of Rajendra Nagar, Coolipara, Ward No-01, SMC, PS- Pradhan Nagar, Dist. Darjeeling and recovered 40 (forty) bottles of 40 (forty) sealed bottles of Codeine Phosphate & Triprolidine Hydrochloride Syrup cough syrup "REXLEY-T" each bottle containing 100 ml. i.e total (40 X 100 ml= 4000 ml) having batch No MLS26008, Mfg date 01/26, Exp date 12/27, MRP Rs 180.00/- each from the said brown colour cartoon under the possession of said detained person namely Naresh Kamti (38 yrs) S/O Promod Kamti of Rajendra Nagar, Coolipara, Ward No-01, SMC, PS- Pradhan Nagar, Dist. Darjeeling. On demand in presence of you and independent witnesses, the above named detained person failed to produce any valid document/papers for possessing or carrying such huge quantities of Codeine Phosphate based Cough Syrup. On further grilling, he confessed his guilt and stated that he procured the said quantities of "Codeine Phosphate based Cough Syrup" clandestinely from one of his suppliers for the purpose of selling the same in high rates to his selected customers for his wrongful gain. He also stated that he was running such a business illegally for the last few months for his wrongful gain.

Accordingly, I seized the said articles viz :- (i) one (01) brown Colour cartoon Containing 40 (forty) sealed bottles of Codeine Phosphate & Triprolidine Hydrochloride Syrup cough syrup "REXLEY-T" each bottle containing 100 ml. i.e total (40 X 100 ml= 4000 ml) having batch No MLS26008, Mfg date 01/26, Exp date 12/27, MRP Rs 180.00/- each - Marked as Exhibit- "A" (ii) one maroon colour Scooty having Registration No WB-74-BA-6892 along with key "HONDA GRAZIA" - Marked as Exhibit "B" and (iii) one android Mobile phone blue colour styled as Redmi having IMEI No 864712058320271/864712058320289, Mobile No- 9170291120337- Marked as Exhibit "C" from the possession of accused person namely Naresh Kamti (38 yrs) S/O Promod Kamti of Rajendra Nagar, Coolipara, Ward No-01, SMC, PS- Pradhan Nagar, Dist. Darjeeling under proper seizure list in presence of you and independent witnesses and obtained their signatures which is acknowledged by the accused person. Subsequently, I sealed and labelled the seized contraband articles in presence of you and independent witnesses and the above noted accused at the spot. The entire process of search, seizure and labelling were made under the coverage of a video graph executed by the videographer namely Somnath Chatterjee S/O Sushil Chatterjee of Santi Nagar, Boubazar, Ashighar, PS- Bhakti Nagar, Dist. Jalpaiguri at the spot.

From the above noted facts and seizure of incriminating articles, it is quite evident that the offender namely Naresh Kamti (38 yrs) S/O Promod Kamti of Rajendra Nagar, Coolipara, Ward No-01, SMC, PS- Pradhan Nagar, Dist. Darjeeling is involved in procuring and selling "Codeine Phosphate based Cough Syrup" illegally contravening the provisions of NDPS Act. Then, I arrested him after observing all formalities of arrest, informing him regarding the ground of his arrest and brought to Pradhan Nagar PS for further investigation. I also informed to the daughter of the accused namely Namita Kamti over Mobile phone having Mobile No 8653981589 regarding arrest of accused person namely Naresh Kamti from the spot. The seizure and arrest was made in between 23.30 hrs to 23.55 hrs on 18.02.26 as per norms of BNSS.

Under the above fact and circumstances, I pray before you that a specific case under proper sections of law may kindly be registered against the arrested person namely Naresh Kamti (38 yrs) S/O Promod Kamti of Rajendra Nagar, Coolipara, Ward No-01, SMC, PS- Pradhan Nagar, Dist. Darjeeling and arranged its investigation.
