

Sub: Complaint against Debasish Bhattacharya, Kajal Biswasharma and 01 other.

I, Dinesh kumar Rajak, S/o Lt. Brahama Deo Rajak, presently residing in a rented house of Pradip Bhowmik, Vivekananda pally, near kali mandir, upper bagdogra, would like to lodge a complaint against Debasish Bhattacharya, C/o Sisir Kr Bhattacharya, Old Gramain Bank Road, laketown near sunrise club Siliguri (M Corp), P.S: New Jalpaiguri, PIN :734007 West Bengal, Kajal Biswasharma and 01 other. Both Debasish Bhattacharya and kajal Biswasharma are employees of Indian railways. Department : TLAC ELECTRICALS . Office Address : NJP CARRIAGE WAGON DEPOT. Post of Debasish bhattacharya is senior section engineer.

I, the undersigned, respectfully state that on **22/01/2026** at about **08:30 hours**, **Debashish Bhattacharya, Kajal Biswasharma, and one unknown person** came to my residence and **criminally trespassed** into my house. They **brutally assaulted me and threatened me with dire consequences** in front of my wife.

During the said incident, the accused persons **snatched away my mobile phone and a gold ring**. They also **forcibly made me sign on a blank paper and took away my bank cheques bearing cheque numbers, 252677, 252678, 252679, 252680, 252681.** Of SBI. against my will.

The background of the matter is that I had taken a **loan of ₹1,50,000**, and one **Dhananjay Choudhury** had taken **₹1,00,000 for business purposes** from **Debashish Bhattacharya** (relevant documents attached). Out of the said amount, **₹1,52,000 has already been returned**, for which documentary proof is enclosed.

Despite repeated requests and prayers made by me and my wife to allow some time, the accused did not listen. Instead, **Debashish Bhattacharya assaulted me with a blunt iron rod**, causing serious physical and mental injury.

Kajal Biswasharma and the other accused falsely impersonated themselves as police officers and thereafter **Debasish bhattacharya, kajal biswasharma and 1 other forcibly abducted me in their brownish Wagon R car**. Inside the vehicle, they **continuously assaulted me, threatened me, and demanded money**.

Subsequently, they **forcefully took me to the residence of Mr. Raaj Malhotra's sister**, where they also **assaulted Mr. Raaj Malhotra, who had just been discharged from the hospital after undergoing surgery**.

The conduct of the accused persons clearly shows that they are **fearless and have no respect for law**. Even after the said incident, they have been **continuously threatening me over phone calls**,
