Sir,

It is to inform you that I, **Debraj Das**, S/O- Kartik Ch Das , DE & SM, Pradhannagar CCC; being empowered by the Electricity Act 2003, do hereby lodge a complaint against **MANOJ KUMAR ROY, S/O- LT RAJ KUMAR ROY**, Address- Cooliepara near Shiv Mandir W No.-01, Dist-Darjeeling, Pin-734003 for *reconnecting a deemed disconnected meter illegally and unauthorizedly and using it for domestic purpose.*

Today i.e, on 19.02.2026(12:15PM), I came to Cooliepara near Shiv Mandir W No.-01, P.S - Pradhannagar, Dist-Darjeeling in my officially hired vehicle for a routine inspection. I was accompanied by (i) Bijay Lakra SE(S&LP), Darjeeling Region (ii) Bhaben Roy SO(S&LP), Darjeeling Region (iii) Rabi Sankar Singh, Sr OE, Pradhannagar CCC & other technical staffs of Pradhannagar CCC.

On inspection of the premises ,after observing all formalities, I found that the meter **RBRT13863** (Consumer Name- **MANOJ KUMAR ROY, Domestic** Category, Con Id-403016451, Date of disconnection-06.12.2023, Status-Deemed) has been reconnected illegally and unauthorizedly and is being used for Domestic purpose.

The meter **RBRT13863** has an outstanding due of Rs.5,937.93/- and LPSC-Rs.2,062.07/- (as on 19.02.2026) I disconnected the connection of **MANOJ KUMAR ROY** & seized the meter **RBRT13863**, after preparing the seizure list duly signed by the witnesses. Local people were present but none appeared.

Seized Articles:

- 1 phase energy meter **RBRT13863**, 240V, 5-30A , Make- L&T(L/R-2891 KWH)

MANOJ KUMAR ROY was present at the premises. He received the Notice, Inspection Sheet & Seizure list. As such, **MANOJ KUMAR ROY**, has reconnected a deemed disconnected meter illegally and unauthorizedly and using it for Domestic purpose and is liable for prosecution U/S 138 1(b) & 135 1(e) of Electricity Act 2003. Hence, you are requested to treat this as FIR.
