Sir,

I, Ranadip Mazumder, S/O :-Late Kalipada Mazumder , AE & Station Manager, Power House CCC , WBSIEDCL empowered by The Indian Electricity Act 2003 amended on 2007 do here by writing to report a serious incident that noticed on 20.02.2026 at Amtala Road, Chayan Para , Dist:-Jalpaiguri which I believe warrants immediate attention and investigation. The incident involved an accident by a Vehicle bearing no:- WB73/G4263 with 8 Mtr PCC pole of our electrical installations, that caused significant damage to WBSIEDCL's property and public safety.

As information received from the accident location at 5:30 PM, Our technical team attend the spot immediately at 5:50 PM and found that 01(One) 8 Mtr PCC pole broken & damage of 50 mtr LTOH with damage of other electrical installation due to the accident with the said vehicle. The said vehicle identified at the spot with driver of the vehicle named Sachin Chettri (Mobile No:- 7501089770) during inspection of our technical team.

The total financial losses caused due to this accident are approximately Rs. 23200.00 (Twenty Three Thousand Two Hundred) only.

Given the potential risks and significant financial implications, I kindly request you that a FIR be registered regarding this accident against the said Vehicle WB73/G4263. Your prompt attention to this matter is crucial to ensure the safety of the community and the protection of WBSIEDCL property. This is for your kind information and further needful action please as per law.
