Sir,

I do hereby lodge a complaint empowered by the Electricity Act, 2003, read with further amendments, that Mr. Biplab Poddar, S/O- Late Haripada Poddar, Inspection Address: Majhabari (Near Jermel School), P.O.- Ghogomali, P.S.- Bhaktinagar, District- Jalpaiguri, PIN- 734006 (Consumer ID: 402897294) (Residential Address: East Vivekanandapally, Sanghati More, Ward- 39, Siliguri, P.S- Bhaktinagar, P.O- Rabindra Sarani, District- Jalpaiguri), has committed Theft of Electricity under section: 135(i)(a) & (e) & 138(b) of the Electricity Act, 2003, read with further amendments for the Commercial purpose as stated here under.

On 20.02.2026 at about 12:55 hours, I, Sri Sourav Paul, DE (E) & Station Manager, Subhaspally CCC, WBSEDCL, along with 1. Mr. Bijoy Lakra, SE(E), S&LP unit, Darjeeling Region, WBSEDCL & 2. Mr. Arnab Ray, JE(E) (Grade-II), 3. Mr. Anup Lama, Sr.OE & 4. Mr. Sanjoy Das, Sr.OE, attached with Subhaspally CCC, WBSEDCL, entered into the premises of Mr. Biplab Poddar, S/O- Late Haripada Poddar, Inspection Address: Majhabari (Near Jermel School), P.O.-Ghogomali, P.S.- Bhaktinagar, District- Jalpaiguri, PIN- 734006 (Consumer ID: 402897294), in order to inspect the incoming service line as well as Supervisory Checking purpose.

During inspection, the aforesaid accused, Mr. Biplab Poddar, S/O- Late Haripada Poddar, Inspection Address: Majhabari (Near Jermel School), P.O- Ghogomali, P.S- Bhaktinagar, District- Jalpaiguri, PIN- 734006 (Consumer ID: 402897294), was found consuming Electricity dishonestly in unauthorized manner by Unauthorized Reconnection of the 'Deemed Disconnected' service connection having Consumer ID: 402897294 & Meter No.: LG0286294 which was disconnected due to having outstanding dues of electricity of Rs. 7,084.26 (excluding LPSC) by that time. Moreover, the last meter consumption up to which billing was raised is 5747 KWh. And, during inspection on 20.02.2026, the aforesaid service connection was found 'Physically Live' by unauthorized reconnection of the disconnected service line as well as found consuming electricity through that meter installed in the earmarked premises for Commercial purposes viz. using the electric connection for the purpose (i.e. Commercial) other than for which the usage of electricity was authorized (i.e. Domestic). The Energy Meter: LG0286294 was found performing 'Normal' having last reading of 7755 KWh (Maximum Demand: 2.48 KVA) during seizure of the meter. Thus the service connection was used in unauthorized manner & no further billing could have been possible, because of which WBSEDCL incurred huge amount of loss in revenue.

As the unauthorized use had been detected I immediately with the help of my Technical staff disconnected the Service Connection and seized one number single phase Energy Meter having Meter No.: LG0286294, Make: Landis-Gyr, Rating: 240V, 5-30A, 50Hz, 3200 imp/KWh (L.R.: 7755 KWh) connected with some portion of Incoming service cable & Outgoing wires, which have been used for the aforementioned unauthorized & dishonest use viz-a-viz Pilferage of Electricity (Consumer ID: 402897294, Nature of Use: Commercial), under a proper seizure list & the seized articles were properly packed, labeled and sealed at the spot after observing necessary formalities in presence of the Inspection Team Members & other Witnesses & the Accused Person himself. The inspection team members left the aforesaid premises at 13:35 hours on the same day after observing all formalities.

So the accused person, Mr. Biplab Poddar, S/O- Late Haripada Poddar, Inspection Address: Majhabari (Near Jermel School), P.O.- Ghogomali, P.S.- Bhaktinagar, District- Jalpaiguri, PIN- 734006 (Consumer ID: 402897294) (Residential Address: East Vivekanandapally, Sanghati More, Ward- 39, Siliguri, P.S- Bhaktinagar, P.O- Rabindra Sarani, District- Jalpaiguri), has committed Theft of Electricity under section: 135(i)(a) & (e) & 138(b) of the Electricity Act, 2003, read with further amendments for the Commercial purpose.

So I request you to take cognizance against the aforementioned accused person on this matter and consider this complain as FIR to initiate further necessary action from your end.
