Sir,

I, SI (AB). Gokul Ch. Barman presently posted at Junction Traffic Guard under Siliguri Police Commissionerate lodge this written FIR to the effect that on 21.02.2026 (Saturday) I was detailed to perform traffic controlling duty at Darjeeling more Traffic beat office along with C/407. Siben Saiba, C/661. Sibesh Mandal, C/871. Amit Oraon, LCV/76. Sefali Barman, CV. 357. Sushanta Roy. On the same day at around 16.25 hrs one Army vehicle (Recovery van) having **vehicle No. 25R012407X** coming towards Darjeeling more headed towards Matigara in a high speed. When the said Army vehicle appeared near the traffic beat office at Darjeeling More then one of my fellow Police personel Constable/871. Amit Oraon of the same duty post who was controlling the traffic movement dashed him and as result the on duty Constable/871. Amit Oraon fall on road and the said army vehicle ran upon him as a result Constable/871. Amit Oraon sustained multiple serious blood injuries and immediately brought him to the nearest Neotia Gatewell Hospital by my other colleagues and where the on duty doctor declared him dead. Due to the impact of the incident locals assembled at the spot and due to the congestion the Army vehicle driver escaped from the spot, later I came to learnt that the that Army vehicle (Recovery van) having **vehicle No. 25R012407X** driven by one Amarendra.

Over this facts and circumstances I am informing you that the death of the on duty traffic Constable/871. Amit Oraon occurred due to the rash and negligent driving of the driver named Amarendra of the Army vehicle (Recovery van) having **vehicle No. 25R012407X**.

Therefore I request you that kindly take legal action over this incident and start a case and arrange for it's investigation.
