Sub: Written Complaint against Rahul Dutta of Dabgram, Siliguri and Debraj Saha R/O - Hatimore (Near Nilmoni Club) Subhashpally, Siliguri, and three other men unknown to me; for attempting to murder me and my friend namely Bikram Roy at around 1 a.m on 20.02.2026 (Friday) near Nilmoni club, Hatimore Subhashpally, Siliguri.

Respected Sir,

I Subham Mandal, aged about 29 years, S/o Ranjit Mandal, R/O – Netaji Subhash Road, Bhakti Nagar, Ward No – 35 under Siliguri Municipal Corporation, Siliguri, Dist- Jalpaiguri, P.S – New Jalpaiguri, Pin- 734007 beg to state as follows :-

1. That on the night of 19<sup>th</sup> and 20<sup>th</sup> February, 2026 myself and my friend Bikram Roy, R/O- Dabgram, (Near Balaka Club), Siliguri had been to Nilmoni club to meet our friends. At around 1 a.m on 20.02.2026 when we were leaving from the Nilmoni club, Near Hathi More, Subhash Pally on my bike at the very moment the above named persons along with some other local men, a team of 5 (FIVE) people raised a fight with us with the pretext that the Nilmoni club belongs to them and we should not be present in the locality. They showed their muscle power and started to assault us there.

Apprehending the problem I tried to leave the place on my bike as I started to move the above named Rahul Dutta caught hold of our bike and instantly attacked me and my friend with a solid brick, Both of them had knives in their hand as well . They had come prepared to attack us. I was brutally attacked by them, being hit hard on my head, stabbing on my neck, face and skull. I started bleeding profusely. They were still attacking us and said Debraj Saha snatched my gold chain of 13gm weight.

3. I fled the place on my motor cycle to save my life as well as my friend's life and went to the Siliguri District Hospital immediately which was nearby. Both my friend and myself got treatment there.

Sir my request to you to lodge an F.I.R. against Rahul Dutta, Debraj Saha and three other unknown persons for assaulting me with brick which has caused grievous injuries above my right eye and scalp and knife causing fatal wounds due to which I am suffering from extreme pain and snatching my gold chain and their intention was to kill me. I pray before you to please take strong legal action against them and save my life from these miscreants as I am passing my days in extreme fear and anxiety.

I am attaching herewith medical examination documents issued by Siliguri District Hospital at 2a.m on 20.02.2026(on the same day).
