Respected Sir,

I Sri Pintu Saha, son of. Late Mantu Saha R/o. 2 No. Jyoti Nagar Colony, Ward No.4, P.S.Siliguri,Dist.Darjeeling would like to inform you that today i.e. on 18/02/2026 at about 07.30 p.m. when I was crossing dry fish market situated under Matigara Police Station along with my gas delivery vehicle at that time another commercial Tata Ace vehicle vide no. WB-73-M- 5671 coming from opposite direction and suddenly said vehicle stopped in front of my vehicle and after that I noticed that four (4) persons inside the said vehicle and out of the said four (4) person I already knew the name of two person namely Chandan Shaw and Kundan Shaw both of them are resident of Hemanta Basu Colony, Ward No. 4, P.S. Siliguri, Dist. Darjeeling and when I asked them why they stopped my vehicle during that time they started to use slang languages in respect of me and during time when I protested the same at that time they came out from their vehicle along with some deadly weapons like rod and one sharp cutting knife and after that they told me that if I hand over my gold chain and cash to their hands then they will allow me to go from that place and there after no other alternative way or being a helpless person and also out of fear of death I silently hand over my 8 gms. Gold chain to their hands and after that they demanded cash of Rs. 10,000/- (Rupees Ten Thousand) only from me when I told them I don't have any cash amount in my pocket after listening the same they became ferocious and thereafter they started to assaulted me with the help of above mentioned rod and sharp cutting knife with a clear intention to kill me and due to assaulted by them I sustained multiple injuries in my whole body and this is also right place to mention here that due to assaulted by them I became senseless and after that some pedestrian came to the spot and after seeing said pedestrian the aforesaid persons fled away from the spot but when they leaving the place at that time they all of them threatened to the said pedestrian and told them if any pedestrian or me inform the aforesaid incident to any Police Station then they will kill me in future and after that some pedestrian with the mercy of God took me at nearest health center and I was treated there as a patient So, right now I spend my every minutes with in fear So, with the help of my well-wishers or friends I knocked your door and lodged this complaint before you against the above named persons

Therefore, I request you please take necessary legal action against the above noted persons and also save me from their hands as early as possible.
