With due respect, I am producing herewith the 04 (four) arrested accused persons namely 1] Bittu Paswan (23yrs approx), S/O- Lt. Dilip Paswan of Champasari bot tola, PO+PS- Pradhannagar, Dist- Darjeeling, 2] Nur Islam (23 yrs approx), S/O- Abdul Ali of Champad Gachh, PO- Fulbari, PS- NJP, Dist- Jalpaigri, 3] Chotu Roy (20 yrs approx), S/O- Lt. Mahabir Roy of Mallaguri BRI Colony, PO+PS- Pradhannagar, Dist- Darjeeling 4] Ashim Chhetri (24 years approx), S/O- Raju Chhetri of, PO+PS- Gorubathan, Dist- Kalimpong and the following articles under seizure :-

1. One Iron made die measuring approximately 1.5 feet from the possession of accused named Bittu Paswan.
2. One Torch light and one pair from the possession of accused named Nur Islam.
3. One Hacksaw blade from the possession of accused name Chotu Roy.
4. One iron made shabol measuring approximately 2.5 feet from the possession of accused named Ashim Chhetri.

I, ASI Bikash Roy of Matigara PS, Siliguri Police Commissionerate beg to state that on 21.02.2026 at about 23.40 hrs, I received a secret source information that a gang of miscreants were assembled at a vacant land behind APCR Govt. College at Himachal Vihar, PS- Matigara, Dist.- Darjeeling with deadly weapons and making preparation for committing dacoity at Himachal Vihar area, under Matigara PS. Accordingly, I informed the fact to I/C, Matigara PS and as per his kind order myself along with ASI Dipak Kr. Chhetri, C/868 Sujal Roy, C/523 Sanjit Kundu and C/219 Sanatan Chitrakar all are of Matigara PS, Siliguri Police Commissionerate left for Himachal Vihar behind APCR Govt. College under Matigara PS to work out the information in hand. At about 23.55 hrs on 21.02.2026 we arrived at Himachal Vihar under Matigara in a vacant land behind APCR Govt. College under Matigara PS. After arrival of the spot and as identified by the source we found that 11/12 persons were assembled in a dark place i.e vacant land behind of APCR Govt. College at Himachal Vihar, PS- Matigara, Dist- Darjeeling and they were whispering in a very low voice. Accordingly we cordoned the place properly and approach towards them very slowly and carefully. But seeing the police party they started to flee away but we managed to apprehended four (04) persons of them. On interrogation the apprehended accused persons, they disclosed their name and identity as noted above (not verified) and also disclosed that they assembled there to commit dacoity at Himachal Vihar area under Matigara PS. They also stated that others 6/7 associates were able to fled away from the spot by taking advantages of darkness. On being searched of the apprehended accused persons, found the above noted articles. Accordingly, I seized the above noted articles under proper seizure list and arrested the above noted 04 (four) accused persons under proper memo of arrest and observing all the formalities of arrest. The search seizure and arrest made on 22.02.2026 in between 00.01 hrs to 00.11 hrs. The whole process of seizure was made under videography and the video was made through WB E-Sakhya Application.
