Sir,

In producing herewith 01 (one) arrested accused person named Kishor Jha (36) S/O Sarwan Jha of Dagapur T.E. Gudam Line, Daknikata, P.O. & P.S. Pradhan Nagar, Dist. Darjeeling along with the following seized article under proper seizure list :-

One (01) White colour Dumper displaying Registration No. WB-73-D-9614 loaded with river bed materials.

I ASI Chandan Chakraborty of Matigara P.S, SPC do hereby lodge a Complaint against the above noted accused person to the effect that on 22.02.2026 at around 00:15 hrs. I intercept the above mentioned vehicle loaded with river bed materials at Litchu Bagan, Near Sericulture Office under Matigara P.S. area during my special van duty and in question he disclosed his identity as Kishor Jha (36) S/O Sarwan Jha of Dagapur T.E. Gudam Line, Daknikata, P.O. & P.S. Pradhan Nagar, Dist. Darjeeling. Further he failed to produce any valid documents or papers in respect of the said riverbed materials. There was a sufficient reason to believe that the above noted accused have procured the river bed materials illegally without any proper royalty/ papers as per rule, for selling clandestinely for his wrongful gain. Accordingly, as per the order of I/C Matigara P.S. I seized the above noted vehicle loaded with riverbed materials under proper seizure list and arrested the above noted accused person. The whole process of search, seizure and arrest was made in between on 22.02.2026 in between 00:20 hrs to 00:30 hrs. The whole process of seizure was made under video graph.

Therefore I pray before you a specific case may kindly be started against the above noted accused person named Kishor Jha (36) S/O Sarwan Jha of Dagapur T.E. Gudam Line, Daknikata, P.O. & P.S. Pradhan Nagar, Dist. Darjeeling under proper section of law and arrange for its investigation.
