Sir,

In producing herewith one accused person named Tapan Das (M-35) S/o Sushil Das of Debidanga, Simulguri, Champasari, P.S. Pradhan Nagar, Dist. Darjeeling under arrest along with following articles under proper seizure.

One paper made cartoon containing total of 18 Bottles of Himalayan Gold 60 UP Indian made liquor containing 600 ml in each bottle (Total 600 x 18 = 10.80 liters) Price tagged as Rs. 170/- and marked as Exhibit "A" out of which one bottle taken as sample for examination and marked as Exhibit "A1".

I, ASI Biplab Kumar Das of Pradhan Nagar Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against one accused person named Tapan Das (M-35) S/o Sushil Das of Debidanga, Simulguri, Champasari, P.S. Pradhan Nagar, Dist. Darjeeling to the effect that today on 22.02.2026 while performing special mobile duty at around 14.15 hrs received a source information that one person named Tapan Das is selling liquor in his shop situated at Fish Market under Siliguri Regulated Market under Pradhan Nagar Police Station without any valid license. Accordingly, I informed the matter to the I/C PS and diarized the fact in General Diary vide Pradhan Nagar PS GDE No 1382 dated 22.02.2026 and as per your kind order and direction, I along with SI Laksang Subba, ASI Anwar Abedin, LASI Mithu Kabiraj and C/1411 Ashok Roy, had been to Regulated Market under Pradhan Nagar PS to verify the veracity of source information. On reaching there and as identified by the source found that one person was selling and storing illicit distilled liquor at his shop. Subsequently, I along with my force cordoned the shop and was able to detain the above noted above person. Subsequently, on being asked the apprehended person disclosed his name and identity as noted above and stated that he is the owner of the shop. Further being searched the above noted seized articles were found in his shop. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further interrogation he stated that he is involved in selling and possessing of liquor without any valid license for last 06 (six) months for his illegal gain. Then, I seized and labeled the above mentioned illegal illicit distilled liquor under proper seizure list and subsequently arrested the above mentioned person named Tapan Das (M-35) S/o Sushil Das of Debidanga, Simulguri, Champasari, P.S. Pradhan Nagar, Dist. Darjeeling after observing all sorts of formalities at the spot. The whole process of seizure and label has been made in between 15.05 hrs. to 15.20 hrs at the spot for violating the norms of Bengal Excise Act.

I therefore pray before your good self that a specific case may kindly be initiated against accused Tapan Das (M-35) S/o Sushil Das of Debidanga, Simulguri, Champasari, P.S. Pradhan Nagar, Dist. Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
