Sub: **Sub: Written complaint regarding house-breaking, theft and criminal intimidation.**

Sir,

I, Smt. Hira Debi, wife of Sri Buton Malakar, resident of Adaghat, Devidanga, P.O. Champasari, P.S. Pradhan Nagar, District Darjeeling, do hereby lodge this written complaint for your kind consideration and necessary legal action against the opposite parties namely (1) Parichhan Paswan, (2) Mithun Paswan, Son of Parichhan Paswan, (3) Smt. Sarda Paswan, wife of Parichhan Paswan, (4) Smt. Usha Paswan, wife of Mithun Paswan, all residents of Adaghat, Devidanga, P.O. Champasari, P.S. Pradhan Nagar, Dist. Darjeeling.

That on 17.10.2025, during daytime, I along with my family members had gone to Devidanga Bazar for selling ginger, and at that time no one was present in my house.

That taking advantage of our absence, the above named opposite parties, in furtherance of their common intention, unlawfully and forcibly broke open the lock of my house, trespassed inside and committed house breaking...

That the opposite parties broke a box kept inside my house and committed theft of the following articles:

13 (thirteen) heavy silver bangles.

1 (one) gold ring weighing about 5 grams.

10 (ten) heavy silver nupur (anklets).

Cash amounting to Rs.30,000/-.

Tin wall of my house.

That after some time, my grandson returned home and found the house in a ransacked condition and immediately informed his father Sri Basand

Malakar. Thereafter, we rushed back and found the house broken open and the aforesaid articles missing.

That upon enquiry from local people, it transpired that the above named opposite parties were involved in the said incident.

That when I went to the house of the opposite parties and demanded return of my stolen articles, then the Opposite Party No.1 Parichhan Paswan threatened me with dire consequences and also threatened to kill my grandson. The opposite parties arrogantly stated that they had stolen the articles and that the police would not take any action against them.

That due to such serious threats and fear, I could not immediately approach the police station. That again on 21.02.2026 the opposite parties threatened to kill my grandson.

That due to the constant threat and fear I am living in insecurity.

I therefore request you to kindly treat this complaint as an F.I.R, register a case against the above named opposite parties, investigate the matter and recover the stolen articles and take strict legal action against the opposite parties.
