Sub: Attempt to kill me with a knife by my
husband Sushanta Dey Sarkar,

Sir,

I, Smt. Ramki Dey Sarkar, W/O Sri Sushanta Dey
Sarkar, D/O Sri Tapas Dey, resident of Shirman-
din, Barada pally, P.O: Kadamtala, P.S: Matigara,
District: Darjeeling, West Bengal. would like bring
to your attention the tremendous physical torture
and attempt to kill me by my husband Sushanta
Dey Sarkar.

I was married to my husband Sushanta Dey
Sarkar on 08.05.2017 and since then I have
been residing at my matrimonial house above-
mentioned. My father-in-law, Sri Sunil Dey
Sarkar and my in-laws (1) Smt. Sampa Dey
Sarkar, W/O Ashim Sarkar (2) Smt. Tumpa Ghosh,
W/O Golok Ghosh have been inflicting torture
and harassment on me since the time our
girl child namely Smt. Samridhi Dey Sarkar
is from 09.12.2019. My in-laws always
taunt me that I am not a good female
as I could not bear a male child. On the

month of September 2025 also, I was severely beaten by my father-in-law and my other in-laws and their husbands because I refused to vacate the matrimonial house and go back to my parental house. My in-laws and my husband want to remove me and our 6 year old daughter from the house so that they can put the house on rent. I did not have the courage to make complaint before police because I was alone with my 6 year old girl.

Now it has become a ritual that my husband always comes home in a drunk condition and also drinks and smokes ganja openly in the house in front of our 6 year old girl. He always has 10-12 packets of ganja in his pocket. Whenever I object to him smoking ganja or drinking inside house, my husband severely beats me and vanishes for 2-3 days.

my husband came home in a
drunk state and started to abuse me and
when I objected to him lighting ganja in the
house. he again started to beat me. He be-
cause so furious that he pushed me against
the wall and kicked me in my abdomen
and abused me for bearing a girl child. He
was so intoxicated that he did not care about
me and our child and started to break things
in the house and throw whatever he could
pick with his hands. He then suddenly picked
up a knife from the dining table and
tried to stab me in my neck. To protect
my self, I pushed my husband away
with my legs, he fell on the floor and
then again threw the knife towards my
face and I somehow saved my eyes.
I started shouting and calling people
and pushed him inside a room and locked
the room from outside and called police on
100.

I request you to take strict action against
my husband as he is very adamant and he
threatened me that he will kill me and
our minor 6 year old daughter whenever
he escapes from the room.
