
Sir,

I, Sri Santosh Dey, S/o Late Gopal Chandra Dey, resident of Tilak Road, Hakimpara, P.O & P.S: Siliguri, District Darjeeling, Pin Code L 734001 would like to complaint about a mob attack on me and Dr Mainak Mukherjee, S/o Late Meghbaran Mukherjee, resident of Rajani Bagan, Hill Cart Road.

I and Dr. Mainak Mukherjee was going to a salon situated at "Sree Bhawan", Market Complex, Hill Cart Rd, Ward 6 of SMC, P.O & P.S: Siliguri, West Bengal 734001 at about 2.30 Pm today and while we climbed the stairs of the said building 1<sup>st</sup> floor, near the shop Nazakat Fashion Studio, we noticed that a group of 5-6 individuals were mercilessly beating another person and abusing him by saying "Chor Sala". These group of 5-6 persons had knuckles, a sharp blade type weapon, belt, pipe, iron rod, and thick wire. Dr Mainak Mukherjee who was with me asked them very politely to stop taking law in their own hands and hand over the person to the nearest police station.

On hearing this, the group of persons became very furious and leaving the thief they caught Dr. Mainak Mukherjee by his neck and one person punched him on his eye. The mob then started beating him with iron rod, pipe, wire etc. One of them then took out the sharp blade type weapon and went ahead to stab Dr. Mainak Mukherjee on his neck, somehow, he pushed that person and sustained injury on his neck but could save his life. They had attempted to stab Dr Mainak Mukherjee on his eye and neck multiple times in order to end his life. When I


tried saving Dr. Mukherjee, they also beat me, caught me by my neck for a long time and tried stopping my breath in order to kill me. One person then from the back side took out his belt and started to beat me with it. I sustained severe injuries on my body too. They mob then repeatedly punched me on my abdomen and Dr. mainak Mukherjee on his face and eye and started to say that "Aaj ke baad kabhi kuch dekh nahi payega".

I heard them shouting that "Dangi Para ka chele hai. Jaan se mardenge jyada hero giri dikhayega toh". Then I started shouting and hearing the ruckus the nearby people came and rushed us to the Hospital. Dr. Mainak Mukherjee is still admitted in hospital due to the severe beating and he is unable to see anything with one eye. The mob also threatened that they would come again to the hospital and residence of Dr Mainak Mukherjee and break everything and put in on fire.

We only asked them to stop beating the thief and this is the punishment we got.
