Sir,

I, Ranadip Mazumder, Son of Lt. Kalipada Mazumder, A.E & SM Power House CCC, empowered by The Electricity Act 2003 amendment on 2007 of India do here by lodge this complaint against The Secretary, Kalyani Apartment, having address Block-C, Punjabi Para, W/N-13, P.O.-Sevoke Road, Siliguri, Dist- Darjeeling, P.S Siliguri, Pin-734001, West Bengal.

While on a routine inspection on the site having consumer id 412062060, energy meter no. B2108625, having power connection of WBSEDCL in the name of The Secretary, Kalyani Apartment, in the address Block-C, Punjabi Para, W/N-13, P.O.-Sevoke Road, Siliguri, Dist- Darjeeling, P.S Siliguri, Pin-734001, West Bengal, I, Ranadip Mazumder, Assistant Engineer & Station Manager, Power House CCC, WBSEDCL along with Sri Jyotiska Sengupta, Jr. Manager (O.O.), Power House CCC, WBSEDCL and other technical staffs observed that the energy was being used in an unauthorized manner bypassing the energy meter via direct hooking from Bus Bar. The inspection was carried out in presence of Sri Somnath Swarnakar (Care-Taker of Kalyani Apartment), Sri Arjun Ghimire (Security Guard of Kalyani Apartment) and Sri P.N. Chatterjee (resident of Kalyani Apartment).

We entered the premises at 11:15 hrs on 23.02.2026 after handing over Notice to Sri. P.N. Chatterjee (resident of Kalyani Apartment) present during inspection. Then it was observed that the power was being used in an unauthorized manner bypassing the energy meter via direct hooking from Bus Bar. Therefore committing a crime for theft of power as per section 135 (1) (a) of The Electricity Act 2003 amendment on 2007 of India. Physical load found during inspection is 447 W and accordingly recorded in inspection report. Accordingly the connection was disconnected and the energy meter was seized and labelled. A copy of inspection report, notice and Seizure list (Bentec make, 1 Phase, 240 Volts, (5-30) amps energy meter having Serial No. B2108625 with Last Reading-36711 KWH, property of WBSEDCL) was handed over to Sri. P.N. Chatterjee (resident of Kalyani Apartment) present during inspection. We exited the premises on 12:30 hrs.

Thus you are requested to kindly initiate an investigation against The Secretary, Kalyani Apartment under Section 135 (1) (a) of the Electricity Act 2003 amendment on 2007 of India.
