Respected Sir,

In producing herewith one arrested accused person Md. Bittu (26 Yrs) S/O Lt. Ahmed Ali Of Dangipara near Ashique Manzil, W/No. 06, PS-Siliguri, Dist.-Darjeeling along with the following seized articles viz.

- a) One transparent Zip-lock Plastic Pouch containing total - 369 grams of brownish substances, suspected to be Brown Sugar, seized from the exclusive and conscious possession of Md. Bittu (26 Yrs) S/O Lt. Ahmed Ali Of Dangipara near Ashique Manzil, W/No. 06, PS-Siliguri, Dist.-Darjeeling and marked as 'Exhibit- A'.
- b) One multi-colour plastic hand bag which was used by the arrested accused for carrying the above noted seized article noted in column no. (a).
- c) One grey colour Screen touch android mobile phone having IMEI No. (i) 539951880484952 & (ii) 359951880484945.

I, SI. Kalachand Mandal of Khalpara TOP-II under Siliguri PS, Siliguri Police Commissionerate, do hereby lodge this written complaint against (i) Md. Bittu (26 Yrs) S/O Lt. Ahmed Ali Of Dangipara near Ashique Manzil, W/No. 06, PS-Siliguri, Dist.-Darjeeling (Not verified) and (ii) Md. Jahangir of Coila Depot. near Nepali Busty, W/No. 07, SMC, PS-Siliguri, Dist.-Darjeeling (Not Verified) to the effect that today i.e on 23.02.26 at about 14.25 hrs. received a specific source information that two persons were standing beside Burdwan Road opposite Vishal Mega Mart under Khalpara TOP, possessing huge quantity of contraband narcotic substances likely Brown Sugar to sell the same to their designed customers. Accordingly, the matter was diarized at Khalpara TOP vide Khalpara TOP GDE No. 665 Dated- 23.02.2026 and subsequently, I informed the matter to the O/C, Khalpara TOP in written and being directed, myself along with SI Newton Biswas, ASI. Binod Chherty, ASI. Inzamamul Haque, C/244 Samim Ali, C/1523 Om Prakash Sribastav, all of Khalpara TOP under Siliguri PS, SPC with investigation kit left for Burdwan Road opposite Vishal Mega Mart, Ward No. 07 under Khalpara TOP by Govt. aided vehicle to verify the veracity of the source information. This refers to Khalpara TOP GDE No. 666 Dated- 23.02.2026 and M.C.C No- 155/26 Date-23.02.26. I also informed cameraman namely Ganesh Paswan (42 Yrs) S/O Nathu Paswan Of Vivekananda Road, Ward No. 08, SMC, P.S- Siliguri, Dist.- Darjeeling. Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidences of facility for the escape of the offender.

On the way to Burdwan Road opposite Vishal Mega Mart, Ward No. 07 under Khalpara TOP, I contacted two persons namely (1) Suraj Sahani (39 Yrs) S/O Lt. Madan Sahani of Santoshi Nagar, Ward No. 05, P.S- Siliguri, Dist.- Darjeeling and (2) Md. Muktar Alam (39 Yrs) S/O Lt. Md. Mazir of Jyotinagar Colony, Ward No. 04, P.S- Siliguri, Dist.- Darjeeling and make them aware about the information in hand and requested them to act as witness, if any search and seizure would be made necessary upon which they agreed. Thereafter, at 14.40 hrs, we along with the independent witnesses & cameraman noted above reached at Burdwan Road opposite Vishal Mega Mart, Ward No. 07, Ps-Siliguri, Dist.- Darjeeling and being pointed by the source able to apprehend one person who was standing beside Burdwan Road near Vishal Mega Mart, PS Siliguri, Dist.- Darjeeling. He was carrying a nylon bag in his hand. Thereafter, we disclosed our identity and informed him regarding the information in hand and also informed that he will be searched in person for the said purpose.

On being asked he disclosed his identity as noted above and admitted that he along with Md. Jahangir of Coila Depot. have illegally procured & possessed Brown Sugar without any valid license for selling the same to his designed customers as per their needs. I then gave him option in writing whether he wanted to be searched in presence of an Executive Magistrate or by any Gazetted Officer and he agreed to be searched in presence of any one of the above. Hence, I informed the fact to Shri Prasenjit Biswas, Inspector-in-charge, Siliguri Police Station about the whole matter and request him to be remained present at Burdwan Road opposite Vishal Mega Mart, W/No. 07 under Khalpara TOP, PS-Siliguri, Dist.-Darjeeling and supervise the search and seizure procedure.

Accordingly, at 14.55 hrs. Shri Prasenjit Biswas, I/C, Siliguri Police Station arrived at the spot as a Gazetted Officer to supervise the search & seizure procedure. Then, I offered the

independent witnesses and the accused person to search our police party as per provision of law. Then he searched us and belonging vehicles in presence of Shri Prasenjit Biswas, I/C, Siliguri PS, acting as Gazetted Officer but nothing incriminating was found. In this regards, a nil search list was also prepared.

Thereafter in presence Shri Prasenjit Biswas, Inspector-in-charge, Siliguri Police Station (Gazetted Officer) and 02 (two) independent witnesses, I searched the detained person Md. Bittu (26 Yrs) S/O Lt. Ahmed Ali Of Dangipara near Ashique Manzil, W/No. 06, PS-Siliguri, Dist.-Darjeeling (Not verified) after following all formalities and recovered (a) One transparent Zip-lock Plastic Pouch containing total - 369 grams of brownish substances, suspected to be Brown Sugar, seized from the exclusive and conscious possession of Md. Bittu (26 Yrs) S/O Lt. Ahmed Ali Of Dangipara near Ashique Manzil, W/No. 06, PS-Siliguri, Dist.-Darjeeling and marked as 'Exhibit-A', (b) One multi-colour plastic hand bag which was used by the arrested accused for carrying the above noted seized article noted in column no. (a) and (c) One grey colour Screen touch android mobile phone having IMEI No. (i) 539951880484952 & (ii) 359951880484945.

Further, on demand in presence of Gazetted Officer, Shri Prasenjit Biswas, I/C, Siliguri PS as well as independent witnesses, the above noted detained person failed to produce any valid documents in support of possessing of such contraband.

Being further interrogation, the accused person noted above, admitted in presence of Gazetted Officer and the independent witnesses that he along with Md. Jahangir have procured the above noted illegal Brown Sugar clandestinely for the purpose of selling the same in high rate to their designed customers for their wrongful gain. He also admitted that few minutes ago Md. Jahangir was also present there with him but left the spot just before the Police arrives.

Accordingly, I seized the above noted articles on the spot from the exclusive and conscious possession of the above mentioned accused person under proper seizure list in presence of Shri Prasenjit Biswas, Inspector-in-charge, Siliguri Police Station, acting as Gazetted Officer as well as independent witnesses as noted above. Subsequently, I have labeled the seized article in presence of said Gazetted Officer and independent witnesses. The whole process of seizure and label was made in between 15.10 hrs. to 15.30 hrs. on 23.02.26. The whole process of Search & seizure was conducted under Videography by a professional videographer.

From the above noted facts and seizure of incriminating articles it is quite evident that the accused persons (i) Md. Bittu (26 Yrs) S/O Lt. Ahmed Ali Of Dangipara near Ashique Manzil, W/No. 06, PS-Siliguri, Dist.-Darjeeling (Not verified) and (ii) Md. Jahangir of Coila Depot, near Nepali Busty, W/No. 07, SMC, PS-Siliguri, Dist.-Darjeeling (Not Verified) are involved in procuring and selling of Brown Sugar illegally contravening the norms of NDPS Act. Then, I arrested the above noted accused person after observing all the formalities and informing the ground of his arrest and issued necessary Memo of arrest.

Under the above noted facts and circumstances, I pray to you that a specific case under proper sections of law may kindly be started against the accused (i) Md. Bittu (26 Yrs) S/O Lt. Ahmed Ali Of Dangipara near Ashique Manzil, W/No. 06, PS-Siliguri, Dist.-Darjeeling (Not verified) and (ii) Md. Jahangir of Coila Depot, near Nepali Busty, W/No. 07, SMC, PS-Siliguri, Dist.-Darjeeling (Not Verified) and arrange for its investigation.
