Sub:Complaint against owner of unknown vehicle for damaging WBSEDCL HT<OH infrastructure on Haiderpara Main Road, Surya Sikha More (Hari Paul More), near Canara Bank, W. No. 39, Dist. Jalpaiguri.

Sir,

I, Sri Debanjan Datta, S/O-Sri Ramendra Nath Datta, age 30 years, posted as Assistant Engineer (E) at Siliguri Town Division, WBSEDCL would like to inform you that in the early hours of 22.02.2026 an accident occurred where an unknown vehicle collided with WBSEDCL 11 kV HTOH Pole on Haiderpara Main Road, Surya Sikha More (Hari Paul More), near Canara Bank, W. No. 39, Dist. Jalpaiguri, through which Haiderpara 11 kV Feeder of Rabindranagar 33/11 kV S/Strn of WBSEDCL is passing.

Due to this accident both HT& LTOH infrastructure of WBSEDCL has been damaged, leaving some adjacent areas in no power condition until restoration is completed. On account of this accident, WBSEDCL has to bear a total cost of Rs.1,52,294/- approximately as network restoration charges.

Therefore, you are requested to lodge the complaint & take necessary action against the miscreant accordingly.
