Sub: First Information Report.

Sir,

In producing herewith accused persons namely (i) Md. Fazrul Hoque (40), S/O- Lt Md. Sakiyat Ali of Gouripur, PO/PS- Gouripur, Dist- Dupri, Assam, (ii) Md. Ali (40), S/O- Bhalu Sheikh of Kharpeti, PO/PS-Kharpeti, Dist- Dargoan, Assam (ii) Saha Alam (40), S/O-Md. Mabiuddin of Mangaldahi, PS- Mangaldahi, Dist- Mangaldahi, Assam, (iv) Javed Ali (30), S/O- Suraj Ali of Dalgoan, PS- Dalgoan, Dist- Darrang, (v) Ahar Ali (30), S/O- Kurban Ali of Mangaldahi, PS- Mangaldahi, Dist- Mangaldahi, Assam under arrest along with seized article under seizure as per enclosed seizure list.

I, SI Sunil Gurung, presently attached with NJP PS under Siliguri Police Commissionerate lodge a written complaint against the above noted accused persons to the effect that today (on 17.02.2026) while performing the K-40 evening mobile van duty vide MCC No-497 Dated 17/02/2026 & NJP PS GDE No- 767 Dated 17/02/2026 I received a reliable source information that huge numbers of buffalos were being transported in in truck bearing no AS 17B 7086 and through Fulbari Toll Plaza towards Assam. If the information would not be pursued immediately, those buffalos would have been concealed in any secret place by this day. Accordingly I Inform the matter to you and as per your kind order myself along with force left for Fulbari Toll Plaza to work out the information in hand I called two independent witnesses namely (i) Gurupada Mandal S/O- Late Tarapada Mandal of Paschim Dhantala, PS- NJP, Dist- Jalpaiguri and (ii) Bikash Barman S/O- Ratan Barman of Mathabanga, PS- Sitalkuchi, Dist- Coochbihar and after disclosing our identity we disclosed the purpose and requested them to accompany with us as independent witness. As they agreed and we along with two witnesses had been to nearby Fulbari Toll Plaza waiting there looking for trucks loaded with buffalos. After waiting for a while we saw one truck with above noted registration number i.e. AS 17B 7086 heading towards Fulbari Toll Plaza. Immediately we intercepted the truck and on checking we found the above noted persons inside the truck and at the backside of the trucks there were 18 nos of buffalos and 18 numbers of buffalos calf respectively. On demand above noted persons were not able to produce any document/ permit to carry live stock or any satisfactory account for possessing the buffalos in the vehicles. Thus it has been made crystal clear and can reasonably be believed that the above noted accd. Persons had procured the buffalos by any illegal means or by means of theft.

During interrogation all of the accused Persons identified themselves as above and admitted their guilt and stated that they deal in stolen cattle and dispose of the same by illegal means for their wrongful gain. They further stated that they procured all the above noted cattle fraudulently from Sufaul Bihar with a view to dispose same to Assam side for wrongful gain.

Accordingly I seized the said truck Bearing Regd. AS- 17B- 7086 and total 36(Thirty Six) numbers of buffalos including calf of different size and colour under proper seizure list in presence of witnesses duly signed by them and arrested the above noted accused Persons issuing proper memo of arrest and communicating them the ground of arrest. The process of the whole seizure took between 21.35 Hrs to 21.50 Hrs. After seizure the buffalos were handed over to Fulbari Cowshed (KHOWAR)

I, therefore pray to you that a case may kindly be started against the above noted accused Persons namely (i) Md. Fazrul Hoque (40), S/O- Lt Md. Sakiyat Ali of Gouripur, PO/PS- Gouripur, Dist- Dupri, Assam, (ii) Md. Ali(40), S/O- Bhalu Sheikh of Kharpeti, PO/PS-Kharpeti, Dist- Dargoan, Assam (ii) Saha Alam(40), S/O-Md. Mabiuddin of Mangaldahi, PS- Mangaldahi, Dist- Mangaldahi, Assam, (iv) Javed Ali (30), S/O- Suraj Ali of Dalgoan, PS- Dalgoan, Dist- Darrang, (v) Ahar Ali (30), S/O- Kurban Ali of Mangaldahi, PS- Mangaldahi, Dist- Mangaldahi, Assam and other associates under proper section of Law and to arrange for its investigation.
