Sir,

I, Bappa Laha, S/o LT. Bhuban Ch, Laha, Residing at Saktigarh, Siliguri, working as a driver of a hired vehicle, bearing Vehicle No WB73-G /6571 under Teesta Design Division, Tinbatti, Siliguri, Like to inform you that on 17/02/2026 when I was returning from Teesta Barrage with my Executive Engineer at 6:15 p.m., an unfortunate incident took place in front of Gate No. 7, Ward No. 32, Teesta Barrage Compound premises.

Suddenly a miscreant, Ata Roy, (Resident of Jotirmoy Colony) arrive in front of my vehicle. I had to move my vehicle towards the middle but he started using abusive and slang language towards me. I tried to calm him down and requested him politely to stop, but he suddenly blocked my vehicle, and forcefully snatched the key of my car. I then came down from the car, and he continued abusing me.

In the meantime, he called some other persons over his phone, and three more miscreants arrived at the spot. They physically assaulted me and beat me, which causing injuries to my left eye, and head and bleeding started from my head.

My Executive Engineer also came down from the vehicle and tried to stop them.

The security guard present at the premises identified two of the persons involved namely:

1. Bablu Mondal
2. Ata Roy

Both are residents of Jyotirmoy Colony, Nijpara.

I request you to kindly take necessary legal action against the accused persons and register an FIR in this matter. I am ready to cooperate fully with the investigation.
