Honorable Sir,

I Kartik Mitra S/o- Late Kshitish Mitra, R/o- Dabgram Housing QTR. No. UA/111, Purba Dhantala, P.O.- Satellite Township, P.S. - New Jalpaiguri, Dist - Jalpaiguri, W.B. Pin- 734015 beg to state that my elder son Gopal Mitra repeatedly misbehave with me, physically assaults me with the intention to capture my house.

I have tolerated such kind of misbehavior and physical assaults upon me with the hope that he will understand his mistakes and everything will be under control but as I am growing older things are deteriorating day by day as he is conspiring with his mother against me to drive me out of my house and capture the same for his personal gain.

Recently on 29/01/2026 around 10:45 pm in the night my son Gopal Mitra and my wife Bharati Mitra started misbehaving with me over petty issues and all of a sudden my wife caught hold of my hands and my son physically assaulted me, bang my head on the wall and beat me with blows and kicks. My neighbors came and rescued me from their hands else they would have killed me.

I got myself treated at Siliguri Sub Divisional Hospital the same date.

That due to illness I could not report the matter to the police station.

That till now the accused persons are not allowing me to stay peacefully in my own house.

Presently I am staying with my younger son Tapas Mitra in his rented house who was also driven out from the house by Gopal Mitra and Bharati Mitra way back.

I am almost 64 years age, become feeble due to the physical and mental torture of my son and wife and leading a very miserable and scared life.

Hence I request you to take stern action against them.

I also request you to kindly condone the delay in reporting the matter and accept my First Information report.

I will highly obliged to you if you kindly take notice of the fact and to the needful at the earliest.
