Sir,

With due respect, I am producing herewith the arrested accused persons namely (1) Suman Sarkar (28) S/O Sonu Sarkar of ITI More Vidyasagar Club, P.S.- Bhaktinagar, Dist.- Jalpaiguri (2) Md. Sakil (28) S/O Md. Ahmed of Jore Pakhri, P.S.- NJP, Dist.- Jalpaiguri (3) Pawan Kr. Singh (33) S/O Promod Singh of Jyotinagar Colony, Ward No. 4, P.S.- Siliguri, Dist.- Darjeling. Alongwith following seized articles :

1. One Iron Made Hammer approx length 15" inch, along with wooden butt
2. One Iron made Hasua approx length 23" inch
3. One Oron made sword approx length 38" inch along with wooden butt
4. One blue colour nylon rope
5. One Electric chargeable torch.

I, ASI Manoj Majumder of NJP PS, Siliguri Police Commissionerate beg to state that on 23/02/2026 at 00:15 Hrs while myself along with force were performing night mobile duty, I received a secret source information that a gang of miscreants assembled at Kashmir Colony, Uchamath, under PS- NJP, Dist.- Jalpaiguri with deadly weapons and making preparation for committing dacoity at adjacent areas of Gate Bazar, NJP. Accordingly, I informed the fact to you as well as Asstt Commissioner of Police, East -II, SPC and diarized the fact in General diary vide NJP PS GDE No 1044, Dated 23/02/2026. As per kind order and direction of my superior officer myself along with SI Tanmoy Kundu C/1462 Sajahan Tmang, VP/08 Laxman Roy and CV/824 Niru Yadav left for Kashmir Colony, Ucha Math, under New Jalpaiguri PS, Siliguri Police Commissionerate to work out the information in hand. At about 01:25 hrs we arrived at Kashmir Colony, Ucha Math under New Jalpaiguri PS. We found that 10/11 persons assembled in a dark place at Kashmir Colony, Ucha math and they were whispering in a very low voice. Accordingly we cordoned the place properly and approach towards them very slowly and carefully. But seeing the police party they started to flee away but we the police party managed to apprehended above noted 03 (three) of them. On interrogation the apprehended accused persons disclosed their name and identity as noted above. During interrogation they made different statement in different time and failed to give any satisfactory reply for their presence with deadly weapons in the middle of the night. On search of the apprehended accused persons I found (i) One Iron Made Hammer approx length 15" inch, along with wooden butt (2) One Iron made Hasua approx length 23" inch (3) One Oron made sword approx length 38" inch along with wooden butt (4) One blue colour nylon rope (5) One Electric chargeable torch from their joint possession.

During further interrogation they admitted their guilt and disclosed that they are assembled at Kashmir Colony, Ucha Math under New Jalpaiguri PS, Dist.- Jalpaiguri and making preparation for committing dacoity at adjacent area of Gate Bazar under New Jalpaiguri PS. Accordingly, I seized the above noted weapon of offence under proper seizure list and arrested the above noted 03 (three) accused persons under proper memo of arrest after observing all the formalities of arrest, issued them Ground of Arrest and brought them to NJP PS. The search seizure, were made in between 01:30 hrs to 01:45 hrs.

Under the above noted fact and circumstance, I therefore pray to you that a specific case under proper section of law may kindly be started against the arrested accused persons namely (1) Suman Sarkar (28) S/O Sonu Sarkar of ITI More Vidyasagar Club, P.S.- Bhaktinagar, Dist.- Jalpaiguri (2) Md. Sakil (28) S/O Md. Ahmed of Jore Pakhri, P.S.- NJP, Dist.- Jalpaiguri (3) Pawan Kr. Singh (33) S/O Promod Singh of Jyotinagar Colony Ward No. 4, P.S.- Siliguri, Dist.- Darjeling. and others and arrange for its investigation.
