Subject: First Information Report

Respected Sir,

I the undersigned would like to draw your kind attention towards the fact that I was legally married with Sri Subhajit Ghosh, Son of Late Naresh Chandra Ghosh, Permanent Resident of South Colony, Post Office and Police Station: Mal, District: Jalpaiguri, Pin Code: 735221 on 28.11.2018, under Special Marriage Act by Marriage Registrar Officer Dipak Kumar Roy at 44/ C, College Para, Police Station: Kotwali and Post Office: Kharai District: Jalpaiguri, West Bengal: 735102. Prior to the marriage, our relationship began in the month of August, 2017. At that time, neither he nor his family members disclosed any information about his personal habits. After the inception of said marriage I started visiting my matrimonial house once a month and stayed there for approximately Twelve to Fifteen (12 to 15) days. Soon after the marriage, I was shocked and devastated to discover that my husband is a habitual drinker and consumes alcohol from the beginning of the day. I further came to know that prior to our marriage, he had been admitted to the Rehabilitation Centre at Siliguri due to his severe alcohol addiction. This fact was deliberately suppressed from me and my family members before the marriage, thereby defrauding us. Due to his constant intoxication, he became extreme violent and aggressive due to which I used to get injuries over my private body parts. Whenever I protested against such inhuman behaviour, he increased the

level of the physical and mental torture. My mother-in-law and sisters-in-law namely Smt. Mithu Ghosh and Smt. Purnima Ghosh always supported his conduct. They abused me in filthy language and repeatedly demanded dowry on several occasions.

Due to unbearable torture and harassment, I was compelled to leave my matrimonial house 11.05.2022.

I further state that my husband developed an illicit relationship with one Sumana Kundu, daughter of Late Swapan Kundu, resident of Basudebpur, GP Hill, Block Hill, P.O and P.S. : Hill, District: Dakshin Dinajpur, Pin Code: 733126. He concealed from the girl the fact that he was already legally married to me. He falsely portrayed me as a girl who is disturbing his peaceful life and creates problems in his life. So the said Sumana Kundu in connivence with my husband mentally harassed and conspired against me, thereby worsening my marital life.

Thereafter, my husband filed a petition under Section 25(1) of the Special Marriage Act, being Matrimonial Suit No. 219 of 2023 in the Court of the Ld. Additional District Judge at Malbazar seeking a decree of divorce. In the said proceeding, Thereafter, I filed an application under section 36 of the Special Marriage Act, 1964 for Maintenance pendent Lite on 16.03.2024 being Misc. Case No. 03 of 2024, arising out of Matrimonial Suit No. 219 of 2023 in the Court of the Ld. Additional District Judge at Malbazar.

That on 20.12.2025 the Ld. Additional District Judge at Malbazar passed a judgement and decreed ex-parte against me. Thereafter I filed an appeal being FAT No. 03 of 2026 before the Hon'ble High Court at Calcutta, Circuit Bench at Jalpaiguri along with the stay application being CAN No. 1 of 2026. On 20.02.2026 the bench of Hon'ble Justice Shampa Sarkar and Hon'ble Justice Smita Das De was pleased to stay of operation of the judgment and decree dated 20.12.2025. I came to know that despite of the

subsisting stay order my husband most illegally is trying to marry said Sumana Kundu before the Marriage Registrar namely Chandana Mandal and also suppressing his marital status. Further enquiry I came to know that my husband will performing his social marriage with the said Sumana Kundu on 09.03.2026.

These acts of my husband clearly disclose offences of cheating, suppression of material facts, cruelty, dowry harassment and bigamy. Under these circumstances I would request you take appropriate steps the abovementioned persons under the suitable provisions of law.
