Monjit Routh, Khudiram Colony, Rail Colony, Subhash Pally, Ward no-18, Siliguri, Dist- Darjeeling, Pin No:734001 for making unauthorised & illegal reconnection of the temporary disconnected service line and metering installation as per The Electricity Act 2003.**

Sir,

I, Sri Bijay Lakra, S.E., S&LP Wing, Darjeeling Region, WBSEDCL, Siliguri do here by lodge complaint against Rajesh Routh (Ph No.7047868229), S/O- Lt. Monjit Routh, Khudiram Colony, Rail Colony, Subhash Pally, Ward no-18, Siliguri, Dist- Darjeeling, Pin No:734001, for having committed offence as stated here under.

On 25.02.2026 at about 01:11 PM. acting on a source information I, along with 1) Sri Bhaben Roy, S.O., S&LP Wing, Darjeeling Region, WBSEDCL, (2) Sri Biswajit Ghosh, Linesman, Hakimpara CCC and other officials of WBSEDCL entered the commercial premises of Rajesh Routh and inspected service installation, metering installation of Consumer ID 403310026 in the name of Rajesh Routh. During inspection it was found that Rajesh Routh is using electricity unauthorisedly & illegally by reconnecting the disconnected service line of the metering installation that was disconnected previously on 18.02.2026 due to non-payment of outstanding energy bill. Total Outstanding dues Rs. 8532.00 (Rupees Eight thousand five hundred and thirty-two only) including the LPSC of Rs. 60.00 (Rupees Sixty only) till the date.

As unauthorised reconnection of the disconnected service line and metering installation was detected, the energy meter, make: Genus Power Infra Ltd, serial no.- GE1088695 installed against Con Id. 403310026, seized by preparing a formal seizure list duly signed by witnesses.

As Rajesh Routh have committed offence u/s 138(1)(b) of Electricity Act 2003 by using electricity illegally & unauthorisedly by reconnecting the disconnected service line, you are requested to take cognizance of the same by treating this complaint as FIR. The seized articles are packed and labelled by me.
