I would like to inform as under

That on 10 02 2026, While I was in Siliguri I was forcefully dragged and Kidnapped by Ram Kalikotey and his 3 associates from Vega Circle Mall Siliguri near White Crow showroom The same can be verified from the CCTV footage of that area

2 That from Vega Circle Mall Siliguri I was forcefully taken in a white Mahindra Scorpio to an office in the area Salbarai Near Glanerys Siliguri where I was confined for two days

3 That I was brutally beaten on my head back and my entire body with sticks and rods by Ram Kalikotey and his 5 associates continuously for two days during my confinement They had also broken my four teeth and my entire body has been brutally assaulted at multiple places The photographs of injury all over my body has been annexed with this complaint as
Annexure 1 collectively

4 That on 11 02 2026 they forced me to execute an agreement and they also forced me to bring my cheque book from my vehicle Thereafter they forced me to sign on six blank cheques of my Axis Bank account no 925010020789881 I do not remember the cheque nos as entire cheque book was taken by them but I say for sure that I had never issued any other cheque of my said axis bank account to anyone as the cheque book was new

5 While I was in the forceful custody of Ram Kalikotey and his associates I heard them planning to kill me and dispose of my body

6 That on 12 02 2026 I somehow managed to escape from the said office in which I was confined and brutally beaten for two days

7 That immediately after escaping from said office out of fear of being kidnapped and killed I directly came back to my

home in Bikmat Namchi Sikkim

8 That as I was in fear that Ram Gopal Kalikotey and his group will again kidnap and assault me therefore I came to my native place Namchi and subjected myself for medical examination before Namchi District Hospital on the following day ie 13 02 2026

9 That as I gave the history of entire incident including assault a call book intimation was sent to Namchi Police Station from Namchi District Hospital as my case was a criminal matter

10 That in view of call book intimation sent from Namchi District Hospital a police official came and took my statement in connection with the incident Thereafter he left me with an assurance that I will be called from police station for formal complaint for registration of Zero FIR into the matter

11 That in view of the assurance of call from Namchi Police Station and also in view of severe pain and multiple injuries I waited for two days for any call from the police station

12 That on 16 02 2026 I was informed by S H O Namchi Police Station that no zero FIR will be registered here and I was advised to lodge my complaint before concerned police station

13 That on 17 02 2026 I came to your esteemed office with my wife for registration of my complaint as the alleged offences are cognizable in nature therefore registration of FIR is mandatory irrespective of the area concerned as per section 173 1 of the BNSS 2023 But your kind office had refused to register my complaint

14 That on 18 02 2026 I was compelled to take legal advise for the remedy available to me Wherein I was advised to send this complaint to your kind office for registration of FIR before approaching Ld Court of Law mandated under section 173 4 of BNSS 2023 through registered post

15 That as I am in fear of being kidnapped killed and assaulted again and also in view of severe pain because of injuries due to assault I am not in a condition to personally lodge the FIR and the concerned police station had denied to verbally accept my complaint Therefore I pray for direction to Station House Officer Namchi for registration of zero FIR into the matter as I am in fear of my life while going to the concerned police station I further pray that strict action against Ram Kalkotey and his 5 associates under penal provisions of law ad also pray for personal security from them due to fear of life



That, on 10/02/2026, While I was in Siliguri, I was forcefully dragged and kidnapped by Ram Kalikotey and his 3 associates from Vega Circle Mall, Siliguri near White Crow showroom. The same can be verified from the CCTV footage of that area.

2. That from Vega Circle Mall Siliguri, I was forcefully taken in a white Mahindra Scorpio to an office in the area Salbarai, Near Glanery's, Siliguri where I was confined for two days.

3. That, I was brutally beaten on my head, back and my entire body with sticks and rods by Ram Kalikotey and his 5 associates continuously for two days during my confinement. They had also broken my four teeth and my entire body has been brutally assaulted at multiple places. The photographs of injury all over my body has been annexed with this complaint as **Annexure – '1' collectively.**
4. That, on 11/02/2026, they forced me to execute an agreement and they also forced me to bring my cheque book from my vehicle. Thereafter, they forced me to sign on six blank cheques of my Axis Bank account no. 925010020789881. I do not remember the cheque nos. as entire cheque book was taken by them, but I say for sure that, I had never issued any other cheque of my said axis bank account to anyone as the cheque book was new.
5. While I was in the forceful custody of Ram Kalikotey and his associates, I heard them planning to kill me and dispose of my body.
6. That, on 12/02/2026, I somehow managed to escape from the said office in which I was confined and brutally beaten for two days.
7. That, immediately after escaping from said office, out of fear of being kidnapped and killed, I directly came back to my home in Bikmat, Namchi, Sikkim.

12. That, on 16/02/2026 I was informed by S.H.O, Namchi Police Station that, no zero FIR will be registered here and I was advised to lodge my complaint before concerned police station.

That, on 17/02/2026, I came to your esteemed office with my wife for registration of my complaint, as the alleged offences are cognizable in nature, therefore, registration of FIR is mandatory irrespective of the area concerned as per section 173(1) of the B.N.S.S,2023. But your kind office had refused to register my complaint.
14. That, on 18/02/2026, I was compelled to take legal advise for the remedy available to me. Wherein, I was advised to send this complaint to your kind
