Respected Sir,

I, **SRI PRAMIT RAY**, Son of Sanjan Kumar Ray, permanent resident of Behala, P.S. Behala, Dist. Kolkata, presently residing at Ashrampara, P.O. & P.S. Siliguri, District – Darjeeling, would like to draw your kind attention to the very effect that I am an employee of CARL ZEISS India Private Limited and currently posted in Siliguri as Area Consultant. On 24/02/2026 I along with my colleague namely Arunava Karmakar went to Jaigaon for our official work, while returning we reached near Payel More at around 11.40 P.M. and at the turning junction of Iscon Road one Red Colour Mahindra Thar bearing registration no. WB74BL7007 parked the said car and blocked the turn. I honked twice and requested the driver of the car to allow us to take the turn. Suddenly the driver of the car and his two associates started abusing me. The said driver who is a well-built person came up to the door of my car and kicked my right door and took me out of my car. Thereafter his associates joined him and all of them together under drunken condition attacked me with fist and blows, one of them hit me at my face with a big stone lying beside the road for which I got grievous hurts, and my nose started to bleed badly. The other associates of the said person took out one iron rod and a wooden battam from their car and mercilessly hit me. One of them hit with one iron rod at my head just with an intent to kill me. I sustained severe bodily pain as well as my nose got dislocated. I finding no other alternative started to shout, the local people came to save us and those above referred antisocial left the place with a threatening of dire consequences. Out of said attack, I received severe grievous injuries including deep cut at my nose and head injuries as well as bodily cut and serious internal injuries in my

nose. I went to Siliguri Dist. Hospital under serious condition (Medical documents copies are annexed herewith) and got two stiches at my nose. The doctors at Siliguri District Hospital advised me to do C.T.Scan and Xray as because from preliminary check-up they told me that there is an internal crack in my nose as well as dislocation of my nasal bone. The said persons in drunken condition voluntarily caused grievous hurt by dangerous weapons as referred above and attempted to murder me under conspiring head as they had such motive. Due to having serious health concern as well as mental shock/panic, the delay caused for filing the present complaint.

I am, therefore, requesting you to take appropriate legal action/s against the antisocial and put them behind the iron bars for the proper administration of justice.
