This is to inform you that there has been a theft in my  
above mentioned factory. As per CCTV footage, the incident  
occurred on 24/02/2026 at around 01:54 A.M.

The thieves has entered the premises by crossing the wall and  
destroying the main power supply. As per initial assessment, all electric  
of lights, camera, fan, camera and stabilizers has been cut  
and stolen. All wires were stolen.

As per the electric technician, the following wires are required  
to restore only the factory lighting :-

- 1mm Copper wire - 8 coils of 90 meters = 720 meters .
- 1.5mm Copper wire - 4 coils of 90 meters = 360 meters .
- 10 Sqmm Copper wire - 60 meters .
- Isolator 4 pole - 1 pc, 3/4" PVC pipe - 50 pcs and other fittings .

The extent of damage to machinery has not been ascertained as  
technicians are yet to come from from the machine suppliers.
