**Subject: FIR regarding road accident of my car Renault Kwid bearing Registration No. WB-74-AR-4546.**

I, Avijit Dutta, S/O Alok Dutta R/O Archindapally, Gokhel Road, Siliguri - 734006, respectfully state that in the early hours of today, 25-02-2026, at about 1:00-1:15 AM, I met with a serious road accident at the Naka checkpoint near Canal More on Fulbari Canal Road.

At the relevant time, I was driving my car a Renault Kwid, Registration No. WB-74-AR-4546 towards the Canal More Naka checkpoint, with two other persons seated inside the vehicle. When I was approaching the Nawapara checkpoint, a truck bearing Registration No. RJ-52-GB-2934, coming from the Fulbari Road side, suddenly took a sharp left turn at the checkpoint at a dangerous speed and in a rash and negligent manner, and violently hit my car.

Subsequently, I spoke with the owner of the said truck regarding the accident. I requested him to help me cover my repairs and pay me compensation for the damage. However, instead of cooperating, the owner threatened me with dire consequences and has stated that even if I lodge an FIR it won't matter as he has high connections.

Sir, the driver of the truck was indeed driving recklessly or else he would not have hit me that too after turning at Nawapara Checkpoint. He was speeding and took the turn in a very rash and reckless manner and the accident could have been more fatal if I would not have controlled my car towards the left. My as well as the life of others seating in my car could have been endangered and the same could have taken a more serious turn of events.

I therefore request you to kindly treat this as my First Information Report and take necessary legal action against the driver and owner of the said truck for rash and negligent driving causing the accident and proceed in accordance with law.
