Sir,

With due respect and humble submission I ASI Pema Dorjee Sherpa of Matigara P.S do hereby lodge this written complaint to the effect that on 27.02.2026 in course of my mobile van duty vide Matigara P.S GDE No. 1676 dated 27.02.2026 received a source information that one vehicle (Dumper) is coming from Khaprail Bazar towards Khaprail More under Matigara PS loaded with river bed material which were procured clandestinely. On receipt of such information, I informed the matter to I/C Matigara PS over phone and as per his kind direction I along with force rushed towards Khaprail Bazar. On the way near Sericulture office under Matigara I intercept one Dumper bearing Registration no. WB-73-D-9055 loaded with river bed materials and detained the driver of the vehicle. During interrogation he disclosed his identity as Suren Oraon (41) S/O Late Arati Oraon of Litchu Bagan, P.O. Nemaï, P.S. Matigara, Dist. Darjeeling. Further in question the driver of the vehicle failed to produce any valid documents in respect of loaded river bed materials. There is every reason to believe that he has procured the loaded river bed materials from somewhere clandestinely and was preceding to sale the same to the designated customer for his wrongful gain. Accordingly as per the order of I/C I seized the above mentioned vehicle loaded with river bed materials under proper seizure list and arrested an accused person named Suren Oraon (41) S/O Late Arati Oraon of Litchu Bagan, P.O. Nemaï, P.S. Matigara, Dist. Darjeeling under proper memo. The seizure was made in between 22:10 hrs. to 22:30 hrs under ESAKSHYA application.

I therefore, pray before you that a specific case under proper section of Law may kindly be started against the accused person named Suren Oraon (41) S/O Late Arati Oraon of Litchu Bagan, P.O. Nemaï, P.S. Matigara, Dist. Darjeeling and arrange for its investigation.
