Sir

With due respect and humble submission I, ASI Raju Prasad Yadav of Matigara P.S. beg to submit that on 27/02/2026 myself along with force were detailed to perform Night Mobile Patrol duty Dated 27/02/2026 and GDE No 1676. . During my said mobile patrol van duty at about 22:45 hrs, I found that one TATA Dumper six wheeler bearing Regn. No- WB 76 A9340 loaded with illegal riverbed materials is coming from Khaprail Bazar, P.S. Matigara. Accordingly I informed the matter to I/C Matigra P.S over phone. After hearing the information he directed me act as per law at once. Accordingly I along with force intercepted said TATA Dumper six wheeler bearing Regn. No- WB 76 A9340 loaded with illegal riverbed materials near Khaprail More, P.S. Matigara, Dist- Darjeeling. On asking the driver of said Vehicle failed to produce any valid document in respect of said loaded of riverbed materials. It may be presumed that the Driver of said TATA Dumper procured the loaded riverbed materials, illegally and dishonestly, stealing by unfair means, for wrongful gain and proceeding to deliver the same to his designated customer. Finding no other alternatives I seized the TATA Dumper six wheeler bearing Regn. No- WB 76 A9340 loaded with illegal riverbed materials, preparing proper Seizure List also arrested the accused driver named Pabin Singha(46) s/o Bhela Singha of Dimajote PO Nimai PS Matigara Dist Darjeeling preparing Memo of Arrest as well as Ground of Arrest informing him the ground of arrest in Bengali language. I brought both the seized Vehicle and accd. Driver to Matigara PS. Search/Seizure and Arrest were made in between 23:05 hrs to 23:25 hrs on 27/02/2026 under proper videography.

Therefore, I pray before your kind honour that a specific case may kindly be registered against the driver of the TATA Dumper named Pabin Singha(46) s/o Bhela Singha of Dimajote PO Nimai PS Matigara Dist Darjeeling and the vehicle bearing Regn. No. WB 76 A 9340 loaded with river bed materials, and arrange for its investigation.
