With due regards, I, **SMT. BABITA BARMAN NEE DAS**, Wife of Sri Prodyut Das, Daughter of Sri Narayan Barman, Presently residing at Rly. Qtr. No. 63-D Mahananda Colony, Ward No. 1 of S.M.C., P.O. & P.S. Pradhan Nagar, District- Darjeeling, PIN- 734003, would like to lodge this written complaint before your good authority to the effect that **SRI PRODYUT DAS**, Son of Sri Samiran Das of Champadighi, Bade Mayna, Gram Panchayat Alal, Block – Gazole, P.O. Mayna, P.S. Gazole, District- Malda is my legally married husband and our marriage was solemnized on 08/12/2023, according to the Special Marriage Act and thereafter social marriage ceremony was performed on 22/01/2024 according to Hindu Rites and Customs, after observing all formalities of a Hindu Marriage on and from my parental house situated at South Ambdkar Colony, Siliguri Junction, P.O. & P.S. Pradhan Nagar, Dist- Darjeeling and after the marriage, my husband brought me at his parental house at Gazole, Malda where we have started to live and cohabited together as husband and wife. In my matrimonial house besides my husband, my parents in-law namely Sri Samiran Das and Smt. Shantona Das and one unmarried brother in-law namely Sri Bidyut Das also residing there. My two sister in-laws namely Smt. Purnima Das, W/O Sri Kartick Das and Smt. Shampa Sarkar, W/O Sri Bishnu Sarkar have been residing in their respective matrimonial house which are just adjacent to my matrimonial house and since the date of my marriage, they along with their husbands have started to interfere in our daily life. My husband is an employee of Railway Department and when our marriage was solemnized, my husband was posted at Siliguri Diesel Shed under N.F.Railway. After staying two months at our matrimonial house at Gazole, Malda, my husband shifted me from Malda to Siliguri and we have started to stay at Jhankar More, Siliguri in a rented premises. It is to be mentioned here that at the time of marriage as per the demand of my in-laws, my parents and nearest relatives have fulfilled all the demands made by my in-laws. Though our marriage was a negotiated marriage but Soon after my marriage, my husband and my parents in-law, married Sister in -laws and their husbands including my brother in-law have started tremendous mental and physical torture upon me on the ground that my complexion is black and my looks is not so good like other women and also told me that if they arrange marriage of my husband with another women, then they will get more dowry. Thereafter, they have started to create pressure upon me to bring more dowry from my parental house and when I refused to bring the same as per their demand, they

have caused physical torture upon me on different occasion. Not only that they have treated me just like their maid servant and they did not allow me either to talk with my parents or to talk with the neighbors and forced me to give my consent on mutual divorce and also threaten me that if I fail to give my consent, then they will not hesitate to ruin my life as they are very influential and nobody will do anything against them. I being a lady of middle class family, always tried to understand my husband and other in-laws not to behave upon me in such a manner, but they did not pay any heed to my request and on contrary they are continuing inhumane torture upon me. immediately after elapse of one month, I realized that I became pregnant and accordingly I told my husband and requested him to produce and consult with the Doctor but he tried to by-pass the matter and thereafter my husband in conspiracy with my other in-law members have started to create pressure upon me to abort the said fetus and constantly started to create torture upon me and when I refused to accept their said proposal, they have clearly stated that they will not take any liability for delivery of the said child and they will also not take any liability for my maintenance and for the upbringing of the said unborn child and during the period of my pregnancy, my parents have borne all the expenditures for my treatment and delivery and finally on 25/10/2024, I gave birth a female child at Ram Krishna Seva Sadan Siliguri whose name is Miss. Hitasha Das. After the delivery of female child, my husband in conspiracy with his family members have increased their torture upon me as to why I gave birth a female child and again they have clearly stated that will not incur any expenses for my maintenance as well as for the upbringing of my daughter and my parents have been incurring all the expenses still now inspite of their financial inability. My husband is a habitual drunker and he has made attack and assault upon me on several occasion with an intention to destroy my life. He stop to provide me the daily basic necessities for me and my daughter and sometimes I have passed my days without having any food and sometimes my neighbor provide me some foods. My husband passed his life lavishly and he used to take his breakfast, lunch and dinner from a reputed hotel without taking any information whether we have take any foods or not. It is also painful to mention here that when my parents have came at the Quarter with an intention to request to my husband to behave properly upon me and my little daughter, he became angry and abused my parents and lodged a false complaint before your good authority against me and my parents and since last few months he started to threatened me to leave the Quarter immediately accompanied my daughter and when I objected to leave the Quarter, he became angry and mercilessly beaten me on being intoxicated but inspite of that, I restrained myself from lodging any complain against my husband and other in-laws for the sake of our future conjugal life and also for the future career of our daughter. On 21/02/2026, at about 09:03 P.M., my husband returned back to the Quarter with a full of intoxicated condition and started to beaten me and my daughter mercilessly with an intention to kill me by trotting my neck but when I started hue and cry to

save my life, some neighbors came to our house and seeing the said situation, my husband left me. Due to the afore said incident, I received severe injuries on my person and treated at Siliguri District Hospital. I also became mentally traumatized due to the said incident for which some delay has been caused for lodging this Written Complaint.

I, therefore, request you to investigate into the matter and please take appropriate strong legal action against my husband namely Pradyut Das, my father in-law Sri Samiran Das, Smt. Shantana Das (Mother in-law), Smt. Purnima Das and Smt. Shampa Sarkar (married Sister in-laws), Sri Kartick Das and Sri Bishnu Sarkar (Husband of my two married sister in-laws) and my brother in-law Sri Bidyut Das as per the provision of law and obliged thereby and it is also my prayer that my husband and my in-laws are restrained not to evict me and my daughter from the railway Quarter being No. 63-D at Mahananda Colony.

Your early action is highly solicited.
