Sir,

In producing herewith one (01) arrested accused person namely Avijit Sunar @ Fuche (21 yrs) S/O Amit Sunar of Babubasa, Debidanga, Champasari, PS- Pradhan Nagar, Dist. Darjeeling under arrest along with the following seizure articles viz :- (i) one (01) paper made cartoon Containing 40 (forty) sealed bottles of Codeine Phosphate & Triprolidine Hydrochloride Syrup " REXLEY-T" Cough Syrup each bottle containing 100 ml. i.e total (40 X 100 ml= 4000 ml) having batch No MLS26008, Mfg date 01/26, Exp date 12/27, MRP Rs 180.00 each - Marked as Exhibit- "A" (ii) one grey colour Scooty (Suzuki Access-125) having Registration No WB-74-BU-8425 along with key- Marked as Exhibit "B" and (iii) one android Mobile phone styled as VIVO 200 Pro 5G having IMEI No 863580076804878, 863580076804860- Marked as Exhibit "C". I, SI Gopal Ch Mandal S/O Late Madhab Ch Mandal of Pradhan Nagar PS, Siliguri Police Commissionerate do hereby lodged this written complaint against the above noted arrested accused person namely Avijit Sunar @ Fuche (21 yrs) S/O Amit Sunar of Babubasa, Debidanga, Champasari, PS- Pradhan Nagar, Dist. Darjeeling to the effect that on 25.02.2026 at 22.15 hrs I received a reliable specific secret source input that one person would be come to Siliguri Junction by a scooty having Regn No WB-74-BU-8425 with huge quantity of illegal Cough Syrup in his possession to deliver the same to his design customer. Accordingly, the matter was diarized in PS General Diary vide Pradhan Nagar PS GDE No. 1598 dated 25.02.2026 and I informed to you in writing. Subsequently, being directed by you at about 22.35 hrs myself along with and others officers and force of Pradhan Nagar PS, SPC left for Siliguri Junction under PS Pradhan Nagar, Dist. Darjeeling without any search warrant or authorization for search which could not be possible to obtain from a competent authority for sudden development of such a sensitive information and also for not giving him opportunity for concealment of evidence or facility for his escape. This refers to Pradhan Nagar PS GDE No. 1599 dated 25.02.2026 and M.C.C. No. 378/26 dated 25.02.2026. I also informed one Videographer namely Somnath Chatterjee S/O Sushil Chatterjee of Arabinda Pally, Gokhel Road, Ward No 22, PS- Siliguri, Dist. Darjeeling over telephone and requested him to come to Siliguri Junction under PS Pradhan Nagar, Dist. Darjeeling with his video camera for the purpose of video graphs if required. On the way, I briefed all the Police personnel properly sharing them the nature of information in hand. I also contact with RT Van officer ASI Bappi Kr Das and share the information with him and directed him to come to Siliguri Junction to accompany as well assist us. At around 22.45 hrs we arrived at Siliguri Junction under PS- Pradhan Nagar, Dist. Darjeeling and contacted with my source while he informed that the person who possessing cough syrup will come to Siliguri Junction near Public Bus Stand entry gate by a scooty having Regn No WB-74-BU-8425 shortly to deliver the same to his customers. Then, I contacted with two available independent persons namely (i) Sovin Sahani (25 yrs) S/O Mukesh Sahani of Reajendra Nagar, Coolipara, PS- Pradhan Nagar, Dist. Darjeeling and (ii) Suraj Paswan (30 yrs) S/O Gopal Paswan of Reajendra Nagar, Coolipara, Ward No-01, PS- Pradhan Nagar, Dist. Darjeeling and shared the information with them and requested them to remain present at the spot and act as independent witness if any search and seizure would be made upon which they agreed and expressed their willingness to co operate with me as well as to act witness. I also issued notice upon the above mentioned two independent witnesses. In the mean time RT mobile officers ASI Bappi Kr Das along with force came to the spot at Siliguri Junction to assist us. Thereafter, I again contacted my source who stated that the suspect carrying illegal cough syrup will come shortly from Hill Cart Road side by a scooty having Registration number WB-74-BU-8425 to deliver the same to his designated customers at Siliguri Junction near Public bus stand Entry Gate. 00.05 hrs on 26.02.26 we noticed that one Motor Cycle was coming from Hill Cart Road side. Accordingly, 00.06 hrs on 26.02.26 we stopped the scooty having the same Registration number as mentioned above at Siliguri Junction near public bus stand entry gate and managed the detain the rider of the said detained scooty. On search the scooty one paper made cartoon was found on the leg passage of the scooty. Thereafter, we disclosed our identities as Police personnel (as 4/5 police personnel were in civil dress for our convenience) and informed him regarding the information in hand. On interrogation, the detained person disclosed his identity as Avijit Sunar @ Fuche (21 yrs) S/O Amit Sunar of Babubasa, Debidanga, Champasari, PS- Pradhan Nagar, Dist. Darjeeling and also disclosed that he is carrying 40 bottles of cough syrup inside the carton in his possession and came there to deliver the same to his designated customer. Then, I issued notice in writing to him whether he wanted to search the paper made cartoon in his possession in presence of an Executive Magistrate or any Gazetted Officer as per norms of u/s 50 of NDPS Act, upon which he agreed to be searched in presence of any of the above noted officers.

Accordingly, I informed the matter to you over mobile phone and requested you to arrange more officers and force and to arrange an executive Magistrate or Gazetted Officer to supervise the entire process of search and if required seizure. At around 00.25 hrs ASI Biplab Kr Das, ASI Bikash Roy and the above mentioned videographer arrived at the spot at Siliguri Junction near public Bus stand entry gate and accompanied with me. Accordingly, I served a notice in writing to the said videographer to videograph the entire process of search and seizure if required. Further at around 00.40 hrs on 26.02.26 you arrived at the spot at Siliguri Junction near public bus entry gate under PS- Pradhan Nagar, Dist- Darjeeling to perform the duty of gazetted officer being the I/C of Pradhan Nagar PS and informed me that due odd hours of night no Executive Magistrate was available and as a gazetted officer you are legally authorised to give order to search the cartoon under the possession of the suspect.

Then, I served a notice to you to supervise the entire process of search and if required of seizure. Thereafter on camera, I offered both the independent witnesses noted above and the detained person to search our Police Personnel as per provisions of law but they denied searching the Police personnel. Then, in presence of you and independent witnesses noted above, I searched the paper made cartoon under the possession of above mentioned detained person namely Avijit Sunar @ Fuche (21 yrs) S/O Amit Sunar of Babubasa, Debidanga, Champasari, PS- Pradhan Nagar, Dist. Darjeeling and recovered 40 (forty) sealed bottles of Codeine Phosphate & Triprolidine Hydrochloride Syrup " REXLEY-T" Cough Syrup each bottle containing 100 ml. i.e total (40 X 100 ml= 4000 ml) having batch No MLS26008, Mfg date 01/26, Exp date 12/27, MRP Rs 180.00 each. On demand in presence of you and independent witnesses, the above named detained person failed to produce any valid document/papers for possessing or carrying such huge quantities of Codeine Phosphate based Cough Syrup. On further grilling, he confessed his guilt and stated that he procured the said quantities of "Codeine Phosphate based Cough Syrup" clandestinely from one of his suppliers for the purpose of selling the same in high rates to his selected customers for his wrongful gain. He also stated that he was running such a business illegally for the last few months for his wrongful gain.


Accordingly, I seized the said articles viz :- (i) one (01) paper made cartoon Containing 40 (forty) sealed bottles of Codeine Phosphate & Triprolidine Hydrochloride Syrup " REXLEY-T" Cough Syrup each bottle containing 100 ml. i.e total (40 X 100 ml= 4000 ml) having batch No MLS26008, Mfg date 01/26, Exp date 12/27, MRP Rs 180.00 each - Marked as Exhibit- "A" (ii) one grey colour Scooty (Suzuki Access-125) having Registration No WB-74-BU-8425 along with key- Marked as Exhibit "B" and (iii) one android Mobile phone styled as VIVO 200 Pro 5G having IMEI No 863580076804878, 863580076804860- Marked as Exhibit "C" from the possession of accused person namely Avijit Sunar @ Fuche (21 yrs) S/O Amit Sunar of Babubasa, Debidanga, Champasari, PS- Pradhan Nagar, Dist. Darjeeling under proper seizure list in presence of you and independent witnesses and obtained their signatures which is acknowledged by the accused person. Subsequently, I sealed and labelled the seized contraband articles in presence of you and independent witnesses and the above noted accused at the spot. The entire process of search, seizure and labelling were made in between 00.45 hrs to 01.35 hrs on 26.02.26 at the spot under the coverage of a video graph executed by the videographer namely Somnath Chatterjee S/O Sushil Chatterjee of Arabinda Pally, Gokhel Road, Ward No 22, PS- Siliguri, Dist. Darjeeling.

From the above noted facts and seizure of incriminating articles, it is quite evident that the offender namely Avijit Sunar @ Fuche (21 yrs) S/O Amit Sunar of Babubasa, Debidanga, Champasari, PS- Pradhan Nagar, Dist. Darjeeling is involved in procuring and selling "Codeine Phosphate based Cough Syrup" illegally contravening the provisions of NDPS Act. Then, I arrested him after observing all formalities of arrest, informing him regarding the ground of his arrest and brought to Pradhan Nagar PS for further investigation. I also informed to the grand mother of the accused namely Annu Singh over Mobile phone having Mobile No 7501077799 regarding arrest of accused person namely Avijit Sunar @ Fuche from the spot.

Under the above fact and circumstances, I pray before you that a specific case under proper sections of law may kindly be registered against the arrested person namely Avijit Sunar @ Fuche (21 yrs) S/O Amit Sunar of Babubasa, Debidanga, Champasari, PS- Pradhan Nagar, Dist. Darjeeling and arranged its investigation.
