Sir,  
In producing herewith one accused person namely Utpal Roy (30 yrs) S/O Goutam Roy of Ashram Para, Balu Busty, Salbari, P.S. Pradhan Nagar, Dist. Darjeeling under arrest along with 12 white colour articles under proper seizure list viz :- (i) one white colour nylon bag containing two paper made cartoon each cartoon containing 12 bottles of "ROYAL CASTLE" Blue Premium Whisky, i.e total (12 x 02= 24 bottles), blended bottled by Mount Distilleries Ltd, Mazitar, Rangpo, Sikkim and for sale Sikkim only, each bottle containing 750 ml, i.e total (24 x 750 ml) = 18 ltrs - Marked as Exhibit "A" out of which one bottle of same taken from each cartoon as sample for examination and Marked as Exhibit "A1" and Exhibit "A2". I, ASI Biplab Kumar Das of Pradhan Nagar Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against one accused person namely Utpal Roy (30 yrs) S/O Goutam Roy of Ashram Para, Balu Busty, Salbari, P.S. Pradhan Nagar, Dist. Darjeeling to the effect that on 27.02.2026 at 23.50 hrs I received a specific source information that one person would be coming to Namchi Bus Stand, near SNT, Siliguri Junction with huge quantity of Sikkim made illegal liquor without any valid documents to deliver the same to his design customer for his wrongfull gain. Accordingly, I diarized the fact in PS General Diary vide Pradhan Nagar PS GDE No 1720 dated 27.02.26 and informed the fact to you. Accordingly, as per your kind order and direction myself along with ASI Prabal Sarkar, ASI Bikash Roy, C/1119 Tanmoy Roy all for Pradhan Nagar PS left for Siliguri Junction by Govt vehicle with investigation kit to verify the veracity of the information. On the way to Siliguri Junction, I contacted with one videographer namely Somnath Chatterjee S/O Sushil Chatterjee of Arabinda Pally, Gokhel Road, Ward No 22, PS-Siliguri, Dist. Darjeeling over telephone and requested him to come to Siliguri Junction under PS Pradhan Nagar, Dist. Darjeeling to videograph the entire process of search and seizure if required. At around 00.01 hrs on 28.02.26 we arrived at Namchi Bus Stand, near SNT, Siliguri Junction and contacted with my source while he stated that the person possessing illegal Sikkim made liquore will come to Namchi Bus Stand near SNT, Siliguri Junction within a short period of time. Then, I contacted with two independent witnesses namely (i) i) Raja Sahani (26 yrs), S/O Chunchun Sahani of Reajendra Nagar, Coolipara, Ward No. 01, PS- Pradhan Nagar, Dist. Darjeeling and (ii) Arun Sahani (25 yrs) S/O Upendar Sahani of Rejendra Nagar, Coolipara, Ward No-01, PS- Pradhan Nagar, Dist. Darjeeling and requested them to remain present at the spot and act as witness upon which they agreed. At around 01.05 hrs on 28.02.26 we noticed that one person with a white colour nylon bag in his possession came to Namchi Bus Stand, near SNT, Siliguri Junction. Being pointed by the source, I cordoned the place from every corner with due care and caution and managed to detain him with a white colour nylon bag in his possession. On interrogation the detained person disclosed his name and identity as noted above and on further interrogation he disclosed that there are total 24 bottles of Sikkim made ID liquor inside the nylon bag in his possession. Further being searched of the white colour nylon bag under the possession of the said accused person namely Utpal Roy (30 yrs) S/O Goutam Roy of Ashram Para, Balu Busty, Salbari, P.S. Pradhan Nagar, Dist. Darjeeling, recovered 24 bottles Sikkim made of ID liquor which were kept inside two separate paper made cartoons. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further interrogation he stated that he collected the said Sikkim made liquor from Sikkim and came to Namchi Bus Stand near SNT, Siliguri Junction to sale the same to his design customers. On further grilling, he confessed his guilt and stated that he procured the said quantities of Sikkim made liquor clandestinely from one of his suppliers of Sikkim for the purpose of selling the same in high rates to his selected customers for his wrongfull gain. Then, I seized and labeled the above mentioned illegal illicit distilled liquor under proper seizure list and subsequently arrested the above mentioned detained person namely Utpal Roy (30 yrs) S/O Goutam Roy of Ashram Para, Balu Busty, Salbari, P.S. Pradhan Nagar, Dist. Darjeeling after observing all formalities of arrest, informing him regarding the ground of his arrest for violating the norms of Bengal Excise Act and brought to Pradhan Nagar PS for further investigation. The entire process of seizure and label has been made in between 01.15 hrs. to 01.35 hrs on 28.02.26 at the spot under the coverage of videography executed by the above mentioned videographer as per norms of BNSS.

I therefore pray before your good self that a specific case may kindly be initiated against accused person namely Utpal Roy (30 yrs) S/O Goutam Roy of Ashram Para, Balu Busty, Salbari, P.S. Pradhan Nagar, Dist. Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
