Dear Sir/Madam,

I, Sourav Paul, DE(E) & SM, Subhaspally CCC, WBSEDCL, hereby lodge a formal complaint regarding malicious injury and unauthorized interference with WBSEDCL electrical infrastructure under Section 139 of the Electricity Act, 2023.

During a site inspection conducted on 27.02.2026 at Shantinagar, Siliguri, it was observed that the stay wire had been illegally uprooted and was left hanging loosely. Such unauthorized alteration of electrical infrastructure has created a serious safety hazard, posing a threat to passers-by and nearby residents.

The above act appears to have been carried out by Mr. Jagannath Sidhya, S/o Krishnnath Sidhya, resident of Shantinagar, Siliguri during the ongoing construction of his house. The malicious damage of WBSEDCL property is a punishable offence under Section 139 of the Electricity Act, 2023.

In view of the seriousness of the matter and the potential risk to public safety, I request you to kindly register an FIR against the above-named individual and initiate necessary legal action at the earliest.
