Respected Sir,

With due respect, in producing herewith 01 (one) arrested accused person named Biru Roy (M/47 years) S/o-Bhusan Roy of vill-Chakiavita, PS-Bhorer Alo, Dist. Jalpaiguri along with the following seized articles as per proper seizure list:

1. 21 (twenty-one) bottles of Indian made liquor "KACHI 70 UP" country spirit (each bottle containing 300 ML), Total quantity-6300ML/6.3L, which was found in a paper made cartoon.

I beg to report that I, ASI Utpal Das, S/o-Lt. Mahadeb Das of Bhorer Alo Police Station, Siliguri Police Commissionerate lodged this written complainant against one Biru Roy (M/47 years) S/o-Bhusan Roy of vill-Chakiavita, PS-Bhorer Alo, Dist. Jalpaiguri to the effect that today i.e. on 28/02/26 at about 22.15 hrs, myself along with force while performing PC mobile van duty (This refers to Bhorer Alo PS GDE No. 1122, Dated. 28/02/26) received a source information that one person from Chakiavita under Bhorer Alo PS has stored huge quantity of liquor for selling the same for his wrongful gain without any documents/license. As per kind instruction of my superior, myself along with force proceeded to Chakiavita under Bhorer Alo PS to work out the veracity of source information. After we reached at the spot and on being identified by the source our police party held raid at the house of the above mentioned person and recovered the above noted articles from his house. During local enquiry it came to learn that he was selling the same in his house since long for his wrongful gain without any valid documents/license. In presence of available witnesses, I seized the above noted articles from his possession after preparing proper seizure list. The process of seizure was started at 22.35 hrs and the whole process of seizure is video-graphed through W.B. E-Sakshya App Portal. I then arrested him after maintaining all formalities. The ground of his arrest has been duly communicated with him in written.

Under the above circumstances, I would like to state that a specific case may kindly be started against the accused person namely Biru Roy (M/47 years) S/o-Bhusan Roy of vill-Chakiavita, PS-Bhorer Alo, Dist. Jalpaiguri under proper section of law and also to arrange for its investigation.
