In producing herewith the accused person named Bipul Singha, aged 26 years, s/o- Dukhan Singha, resident of Sabdalpur, Bakhrabad, PS- Baishnab Nagar, Dist- Malda (Aadhaar No. 5798 0335 0827) under custody along with the following seized articles under proper seizure list:-


- (i) One transparent plastic packet contains substance suspected to be Brown Sugar measuring weight 294 grams and marked as Exhibit- A.
- (ii) One Oppo android mobile phone having IMEI No. 860568064107811 & 860568064107803 and marked as Exhibit- B.
- (iii) Cash Rs. 760/- (INR) in the denomination of Rs. 500/- x 1 note, Rs. 200/- x 1 note, Rs. 20/- x 1 note & Rs. 10/- x 4 notes.
- (iv) One pen drive (SanDisk 16GB) contains audio-video record of search, seizure & arrest.
- (v) Certificate u/s 63(4)(c) BSA mentioning hash value
- (vi) Hash Value document mentioning hash value

I, SI Samik Paul of Bagdogra PS, Siliguri Police Commissionerate do hereby lodge this written complaint against the arrested accused person named Bipul Singha, aged 26 years, s/o- Dukhan Singha, resident of Sabdalpur, Bakhrabad, PS- Baishnab Nagar, Dist- Malda (Aadhaar No. 5798 0335 0827) to the effect that today on 27.02.2026 at 19:05 hrs I received a specific source input that one suspect will come near Khanna hotel beside NH-27 with psychotropic substance suspected to be brown sugar in his possession for delivering the same to his designed customer. He has worn ash colour jacket & ash colour cargo pant (trouser). He could be caught red-handed if raided immediately. The matter was diarized vide Bagdogra PS GDE No. 1385 dated 27.02.2026 and I informed the matter to the Officer-in-Charge of Bagdogra Police Station, S.P.C. As per his kind direction a raiding team is formed consisting SI Debabrata Kundu, ASI Amit Lama, ASI Munna Ahmed, VP/01 Anselam Kujur, VP/02 Pradip Roy & CV/389 Janak Singh, all of Bagdogra PS, S.P.C being headed by me and at 19:20 hrs we left for NH-27 near Khanna hotel under Bagdogra PS by Govt. vehicle No. WB61A/0137 with investigation kit to verify the veracity of the information in hand vides Bagdogra PS GDE No. 1386 dated 27.02.2026 and M.C.C. No. 63/26 dated 27.02.2026. Then, I contacted with the videographer named Nikhil Sarkar, aged 49 years, s/o- Late Bhupendra Sarkar, resident of Loknath Nagar, PS- Bagdogra, Dist- Darjeeling (Ph. No. 9832028145) and issued him notice in writing to accompany us at NH-27 near Khanna hotel to prepare the audio-video record of the whole process of search and seizure, if any and he also accompanied us. Further, I contacted with two independent witnesses named MD Jaminul, aged 22 years, s/o- Late MD Mafijuddin, resident of Digravita, PS- Bagdogra, Dist- Darjeeling (Ph. No. 9547487800) and Shibu Singh, aged 32 years, s/o- Late Tapan Singh, resident of Tumbajote, near Jora bridge, PS- Matigara, Dist- Darjeeling (Ph. No. 7001815745) and issued them notice in writing to remain present with us as independent witness for the purpose of search, seizure, arrest, if any. They expressed their willingness to remain present with us as independent witness. Under these circumstances any search warrant or authorization cannot be obtained without affording opportunity for
